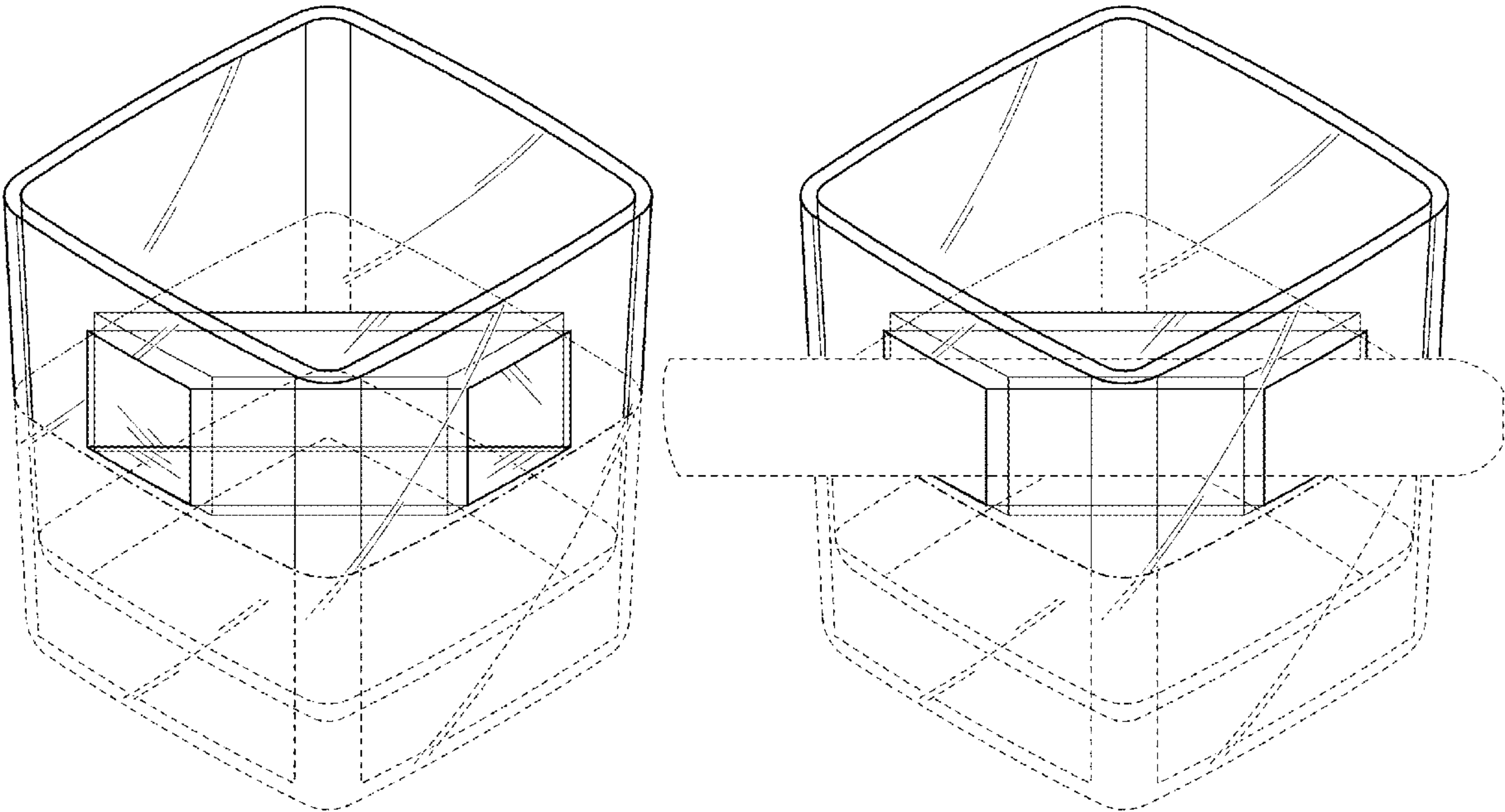
CLAIM

I claim the ornamental design for a cigar glass, as shown and described.

DESCRIPTION

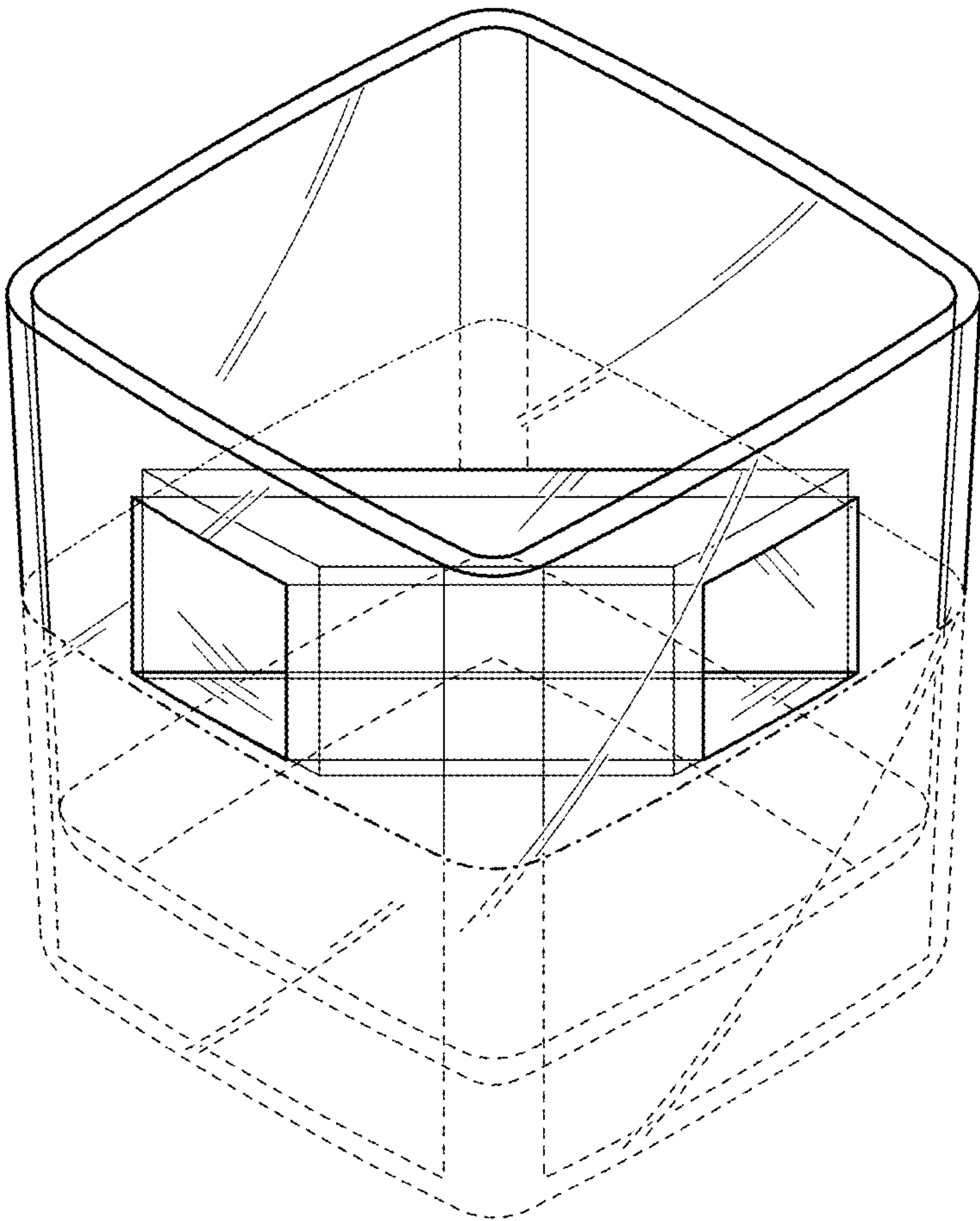

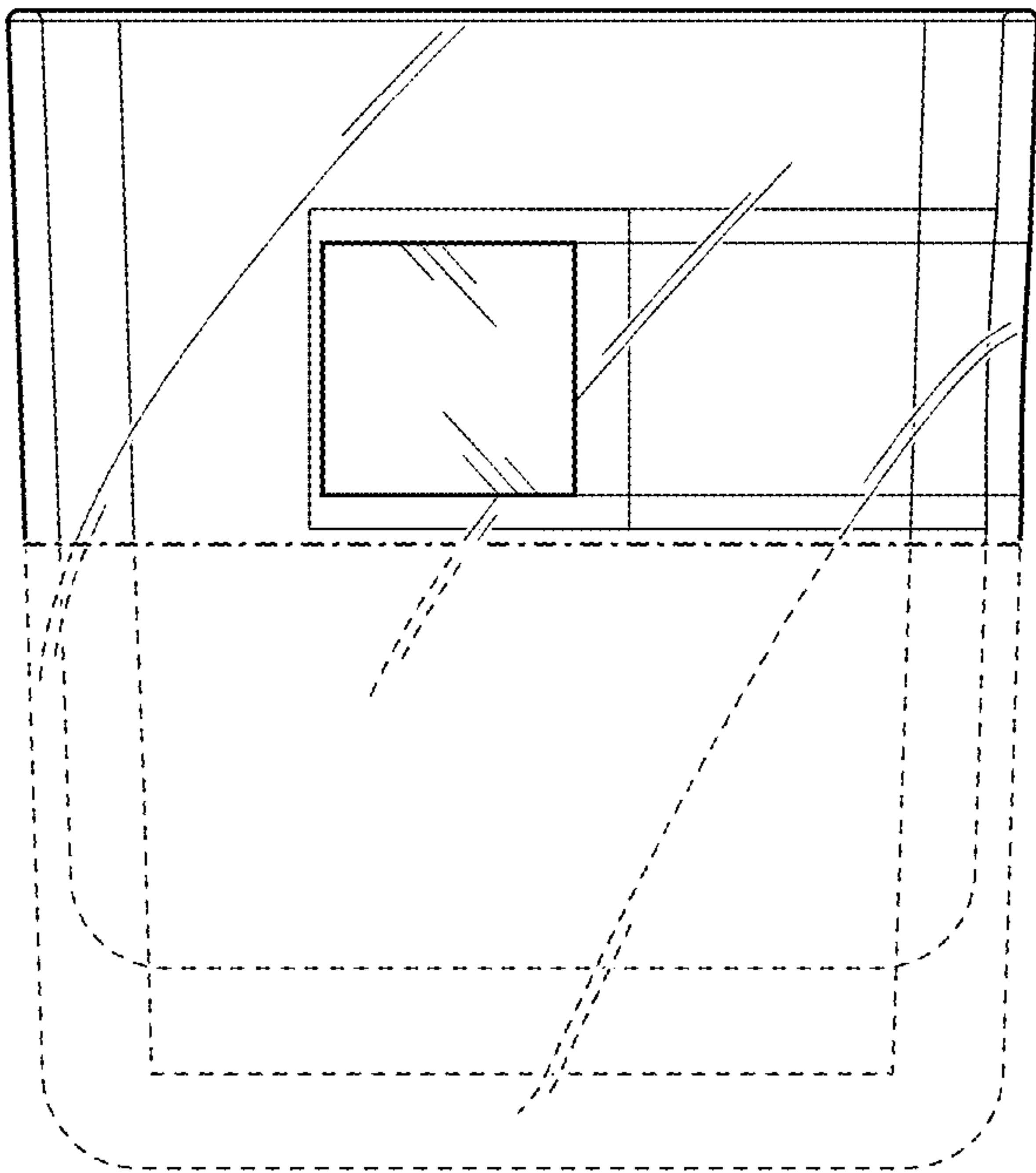

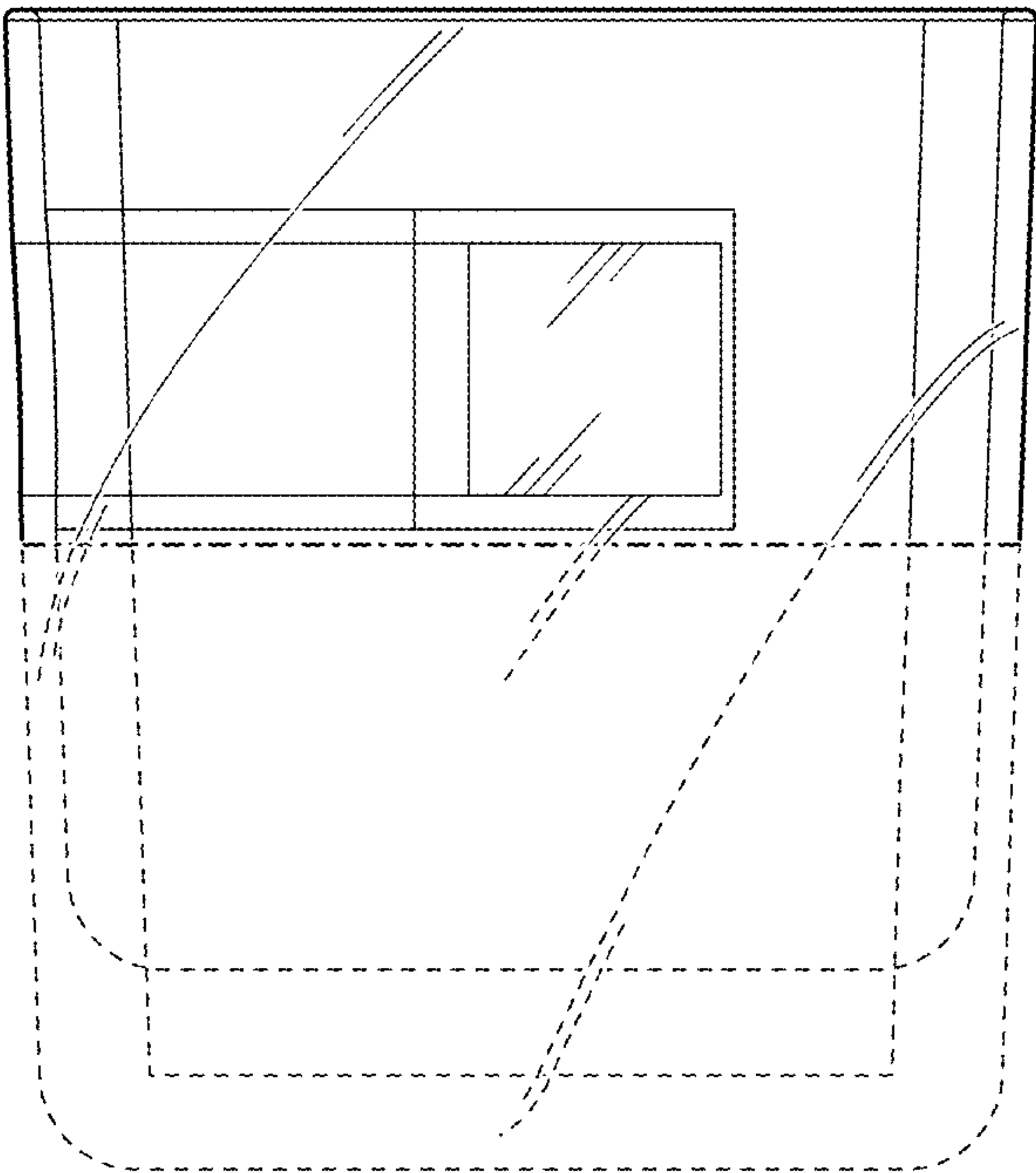

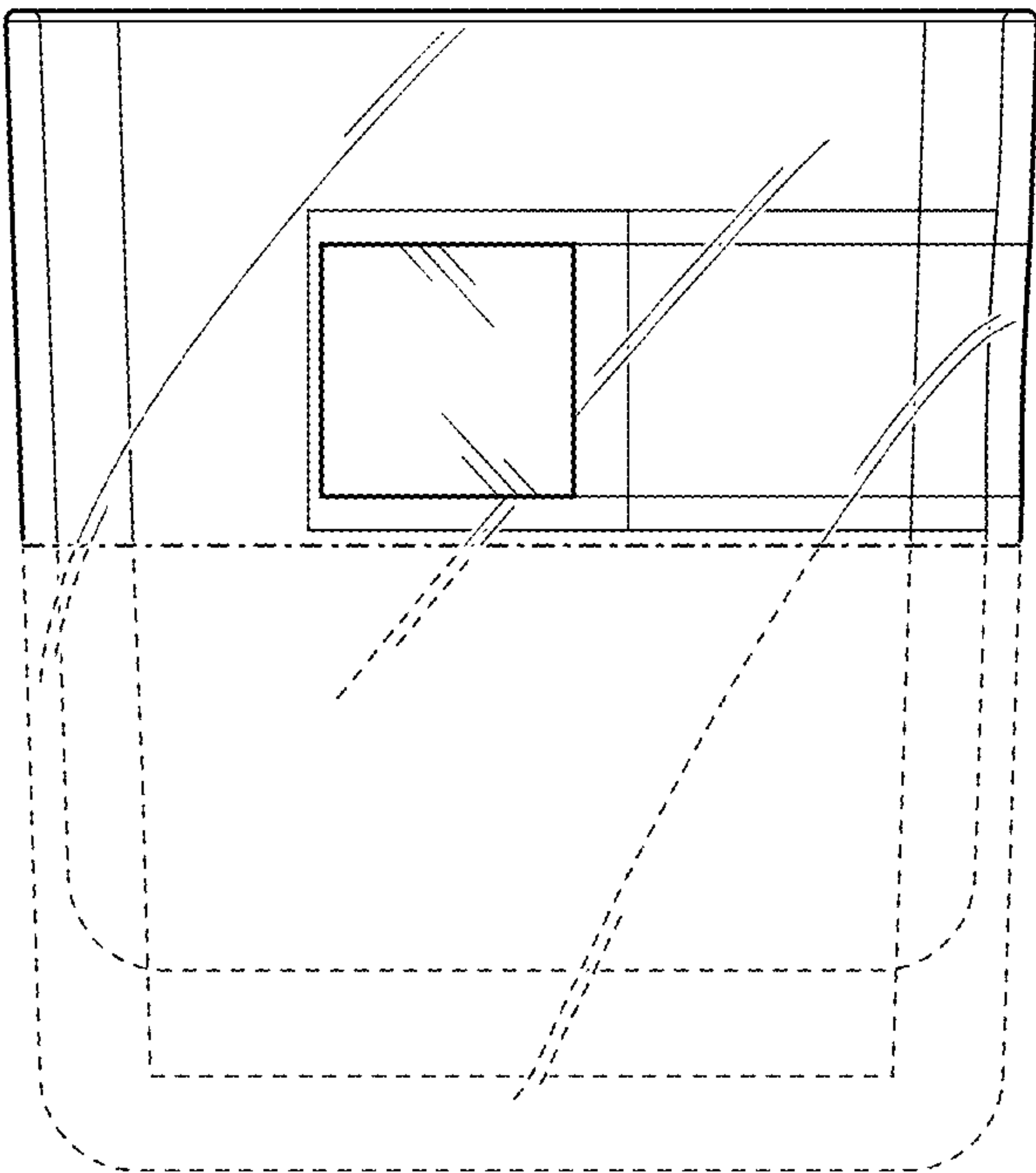

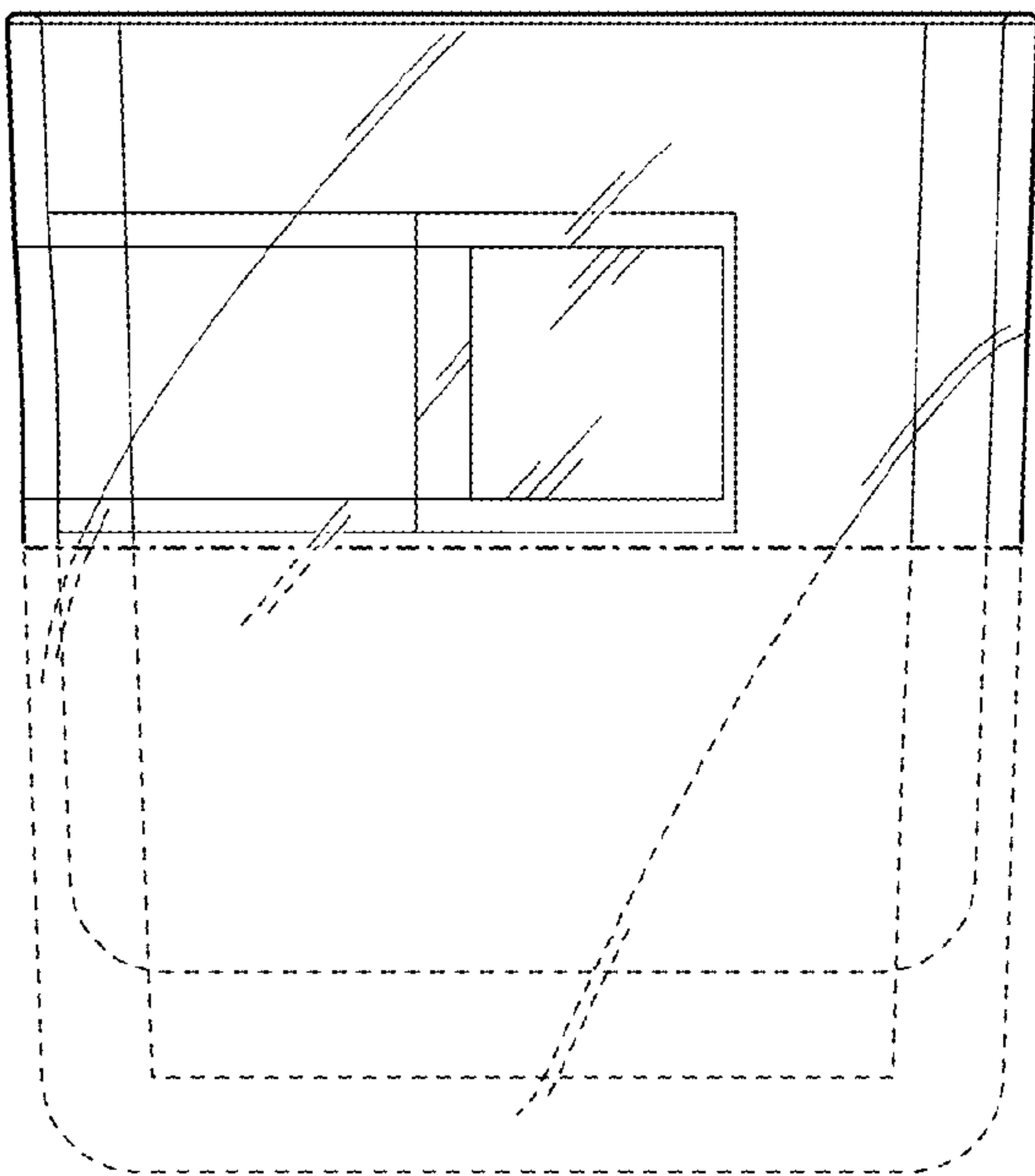

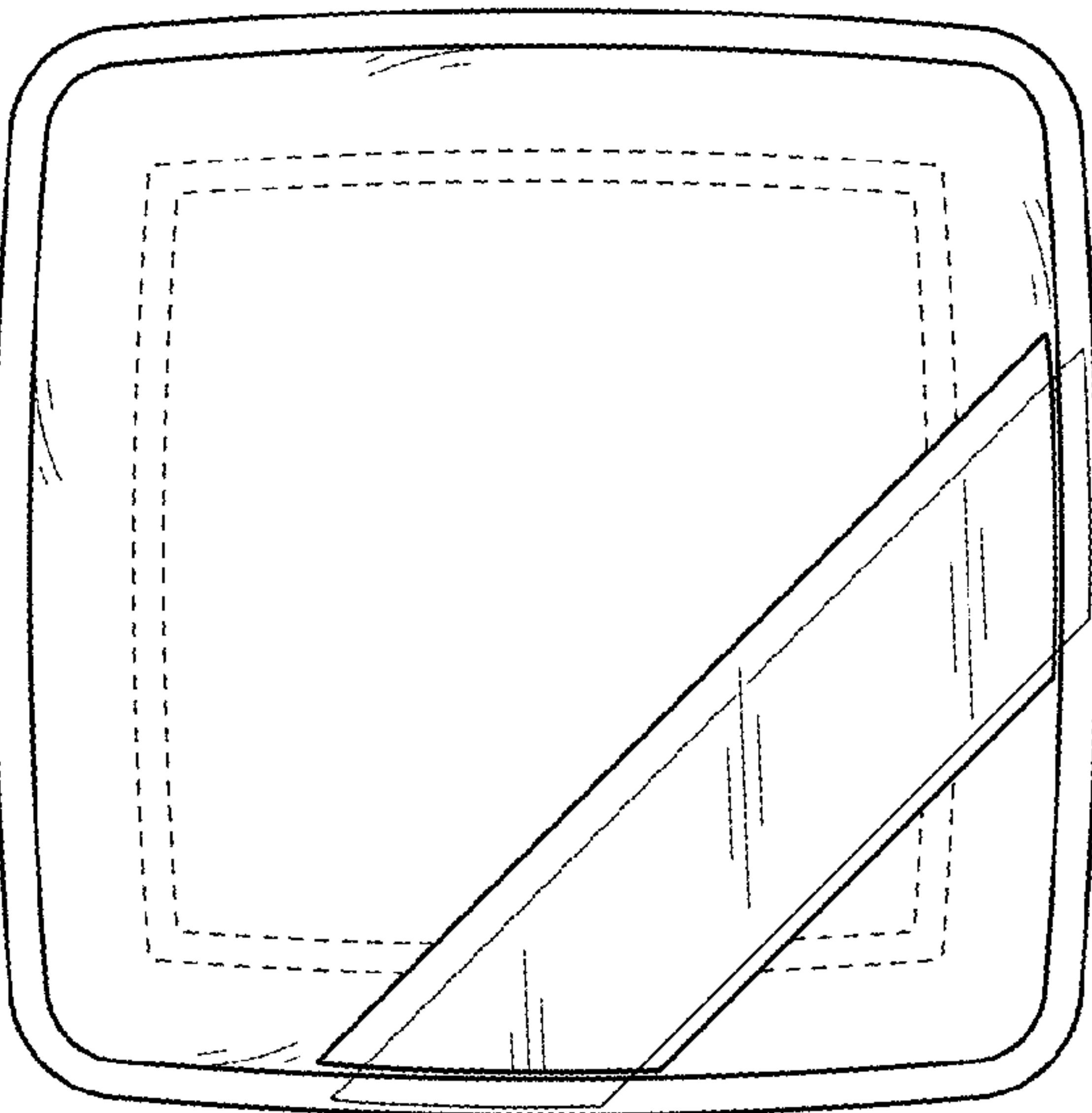

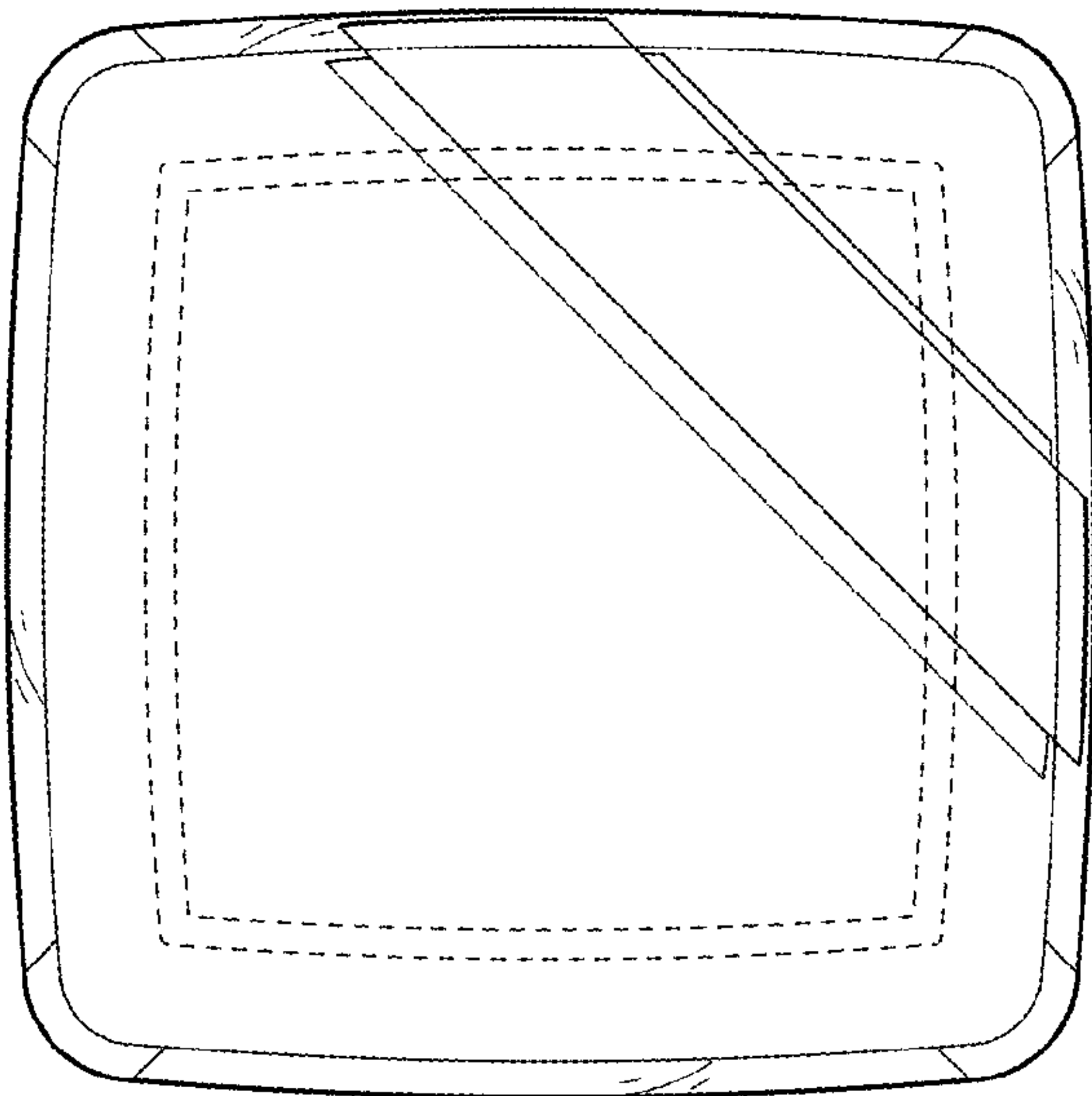

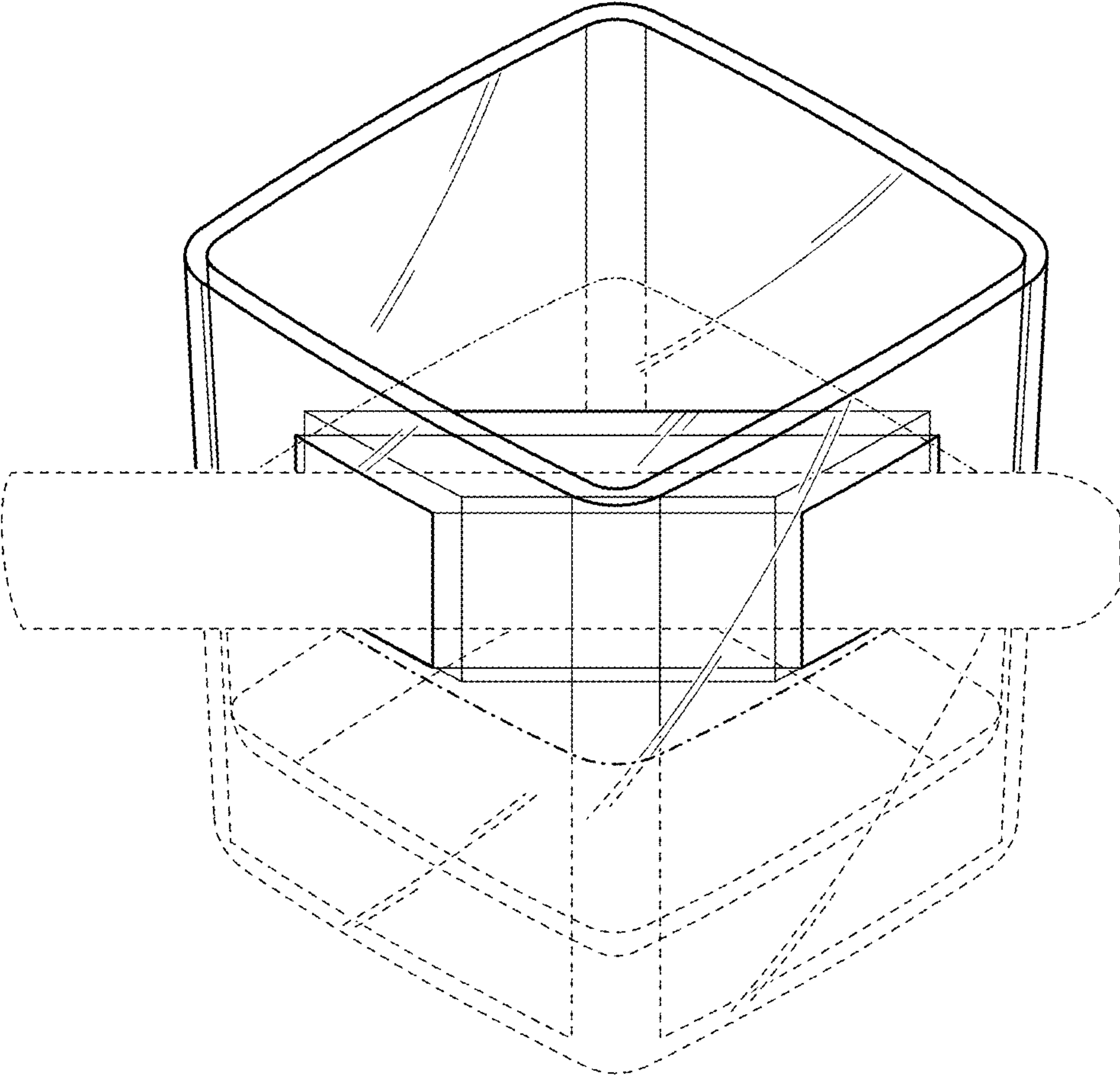
