FIG. 2 is a rear elevational view thereof;

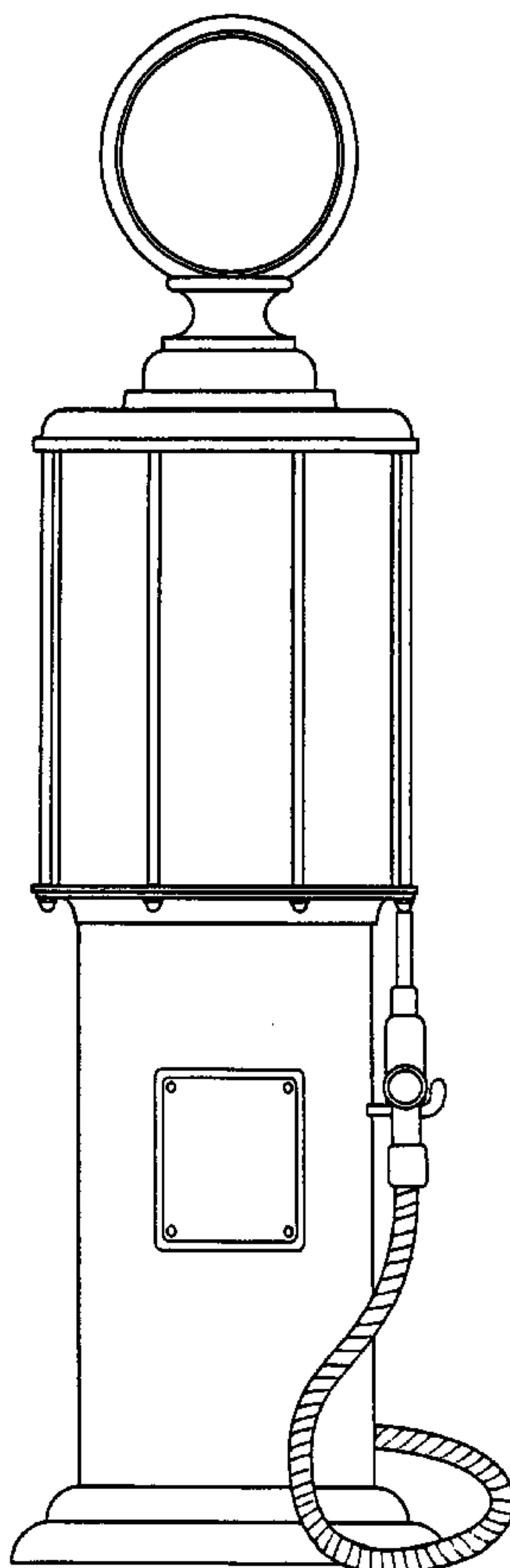
FIG. 3 is a side elevational view thereof, as viewed from the left of FIG. 1;

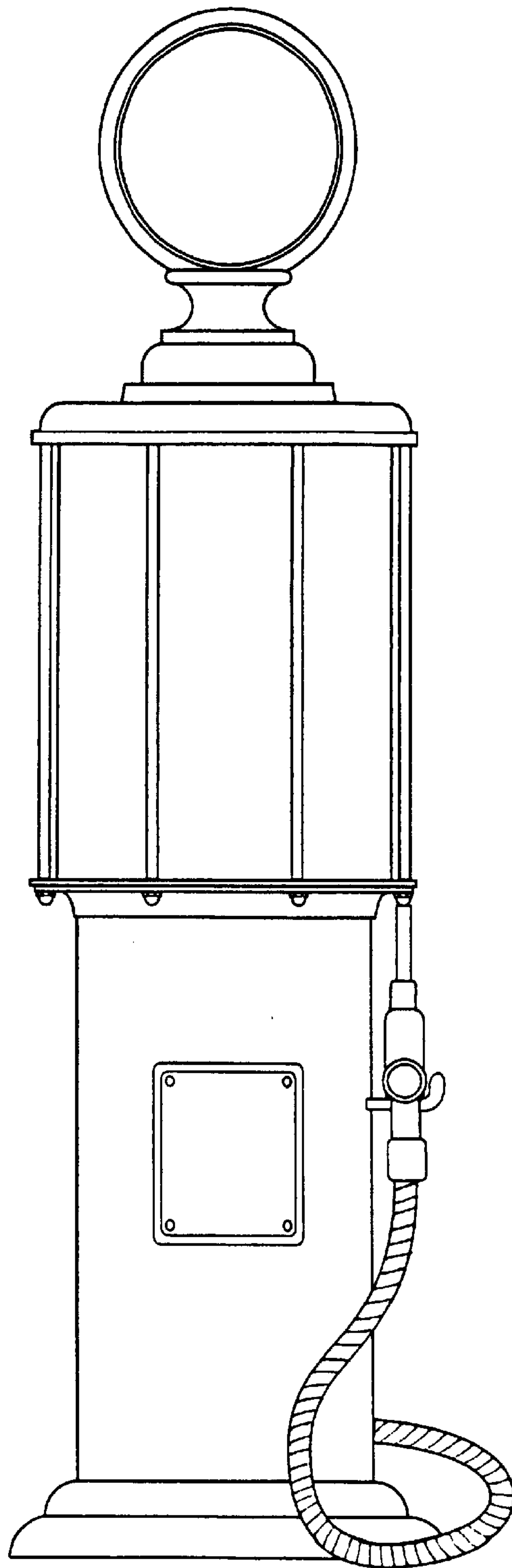

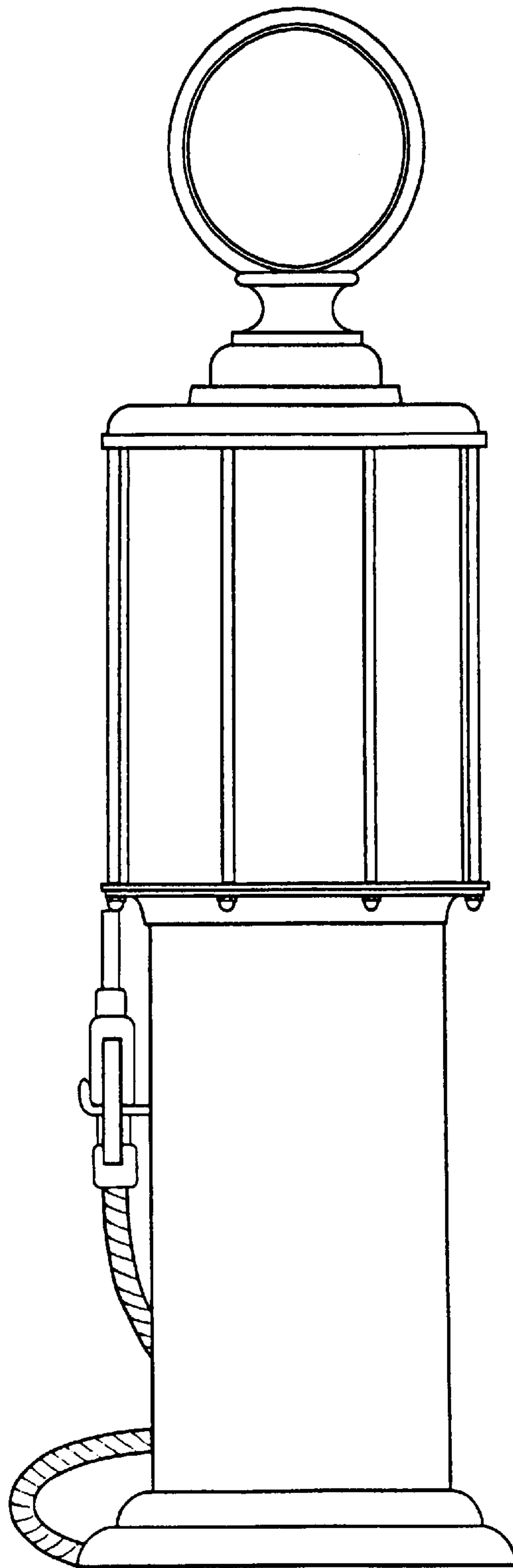

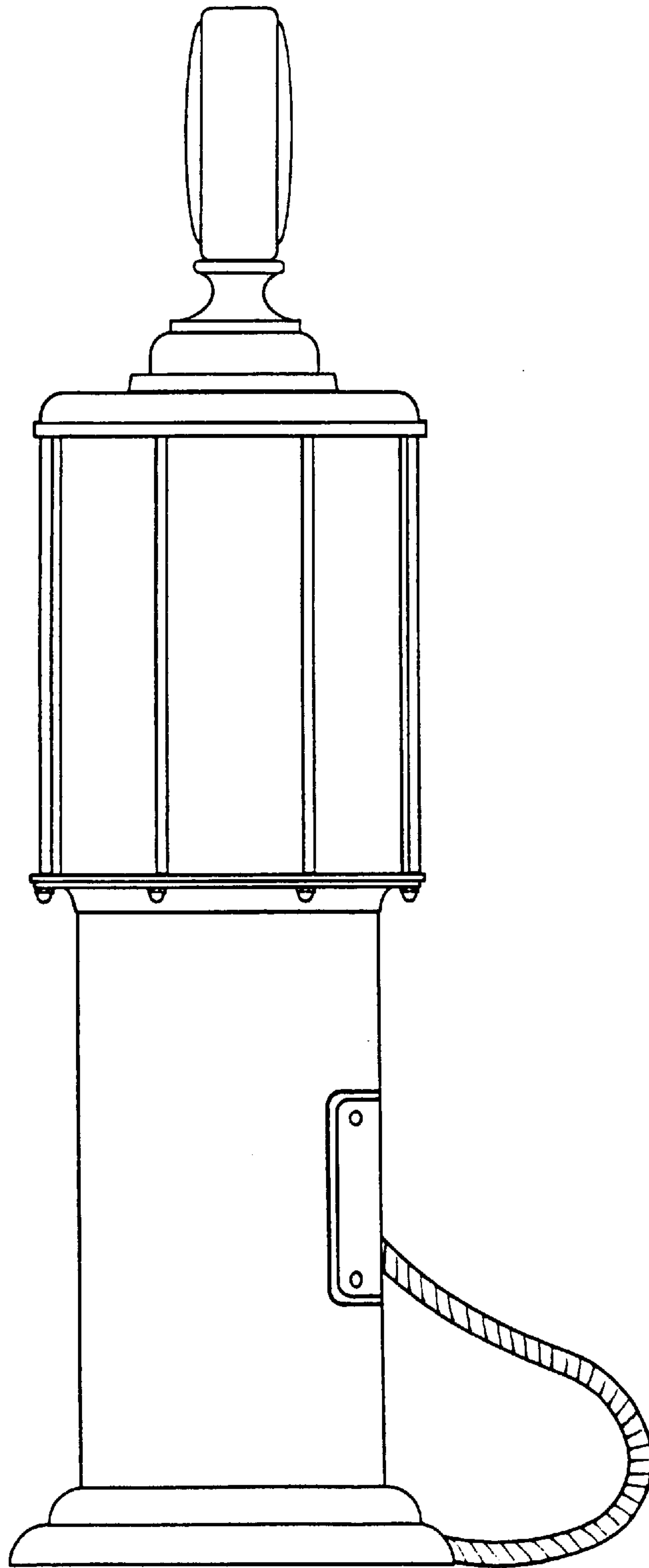

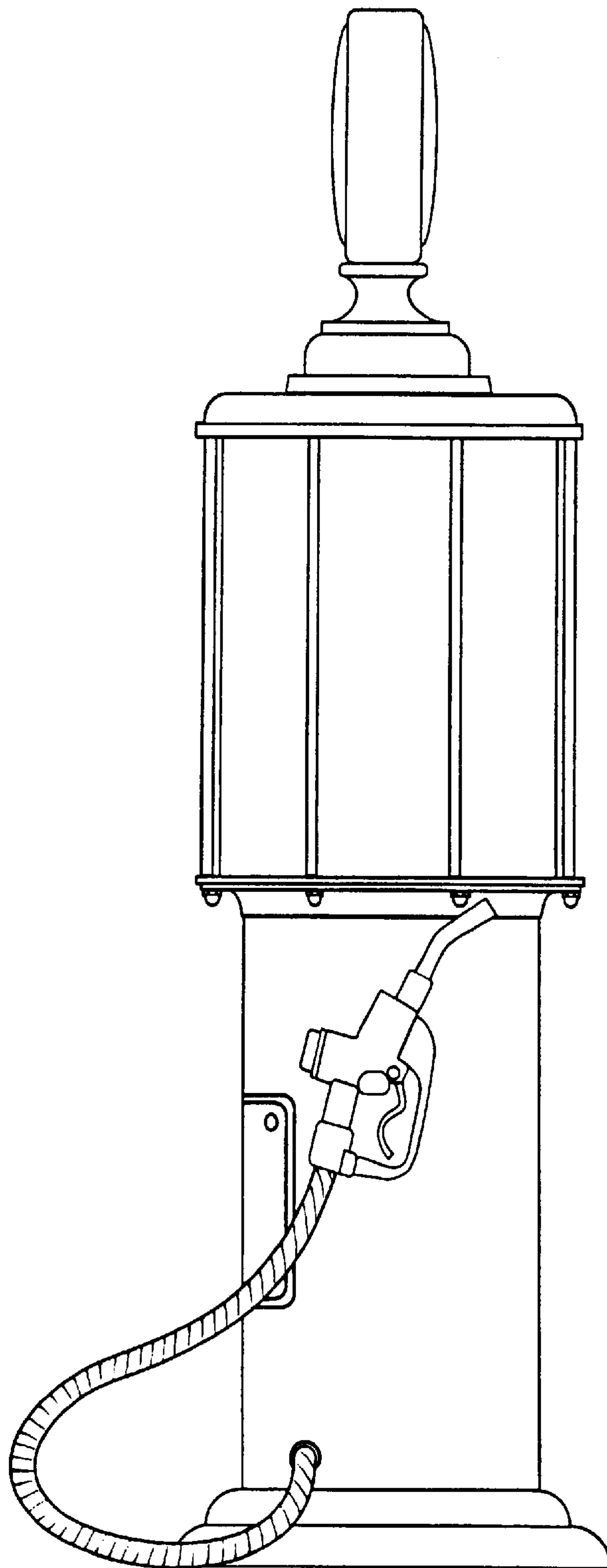

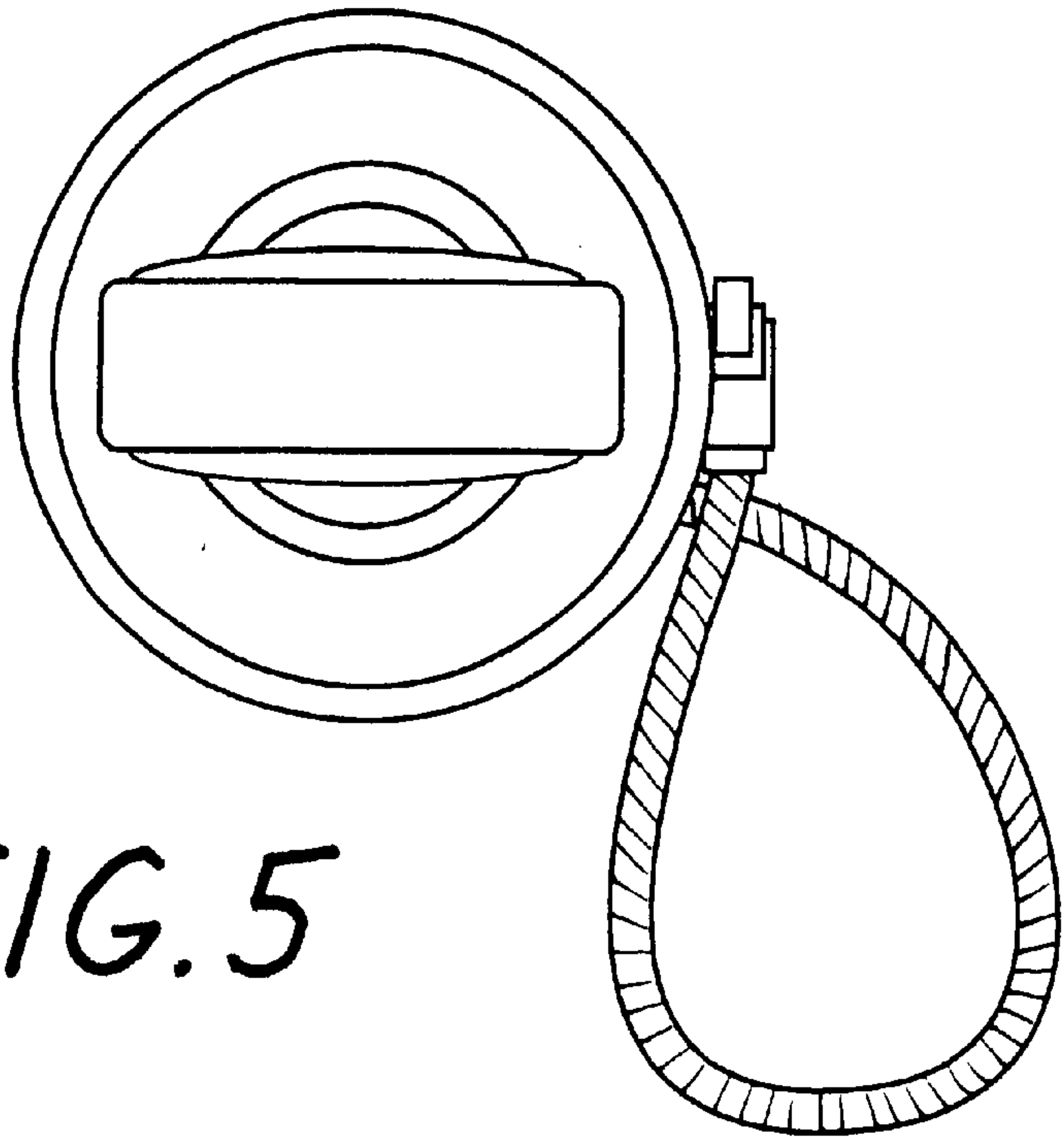

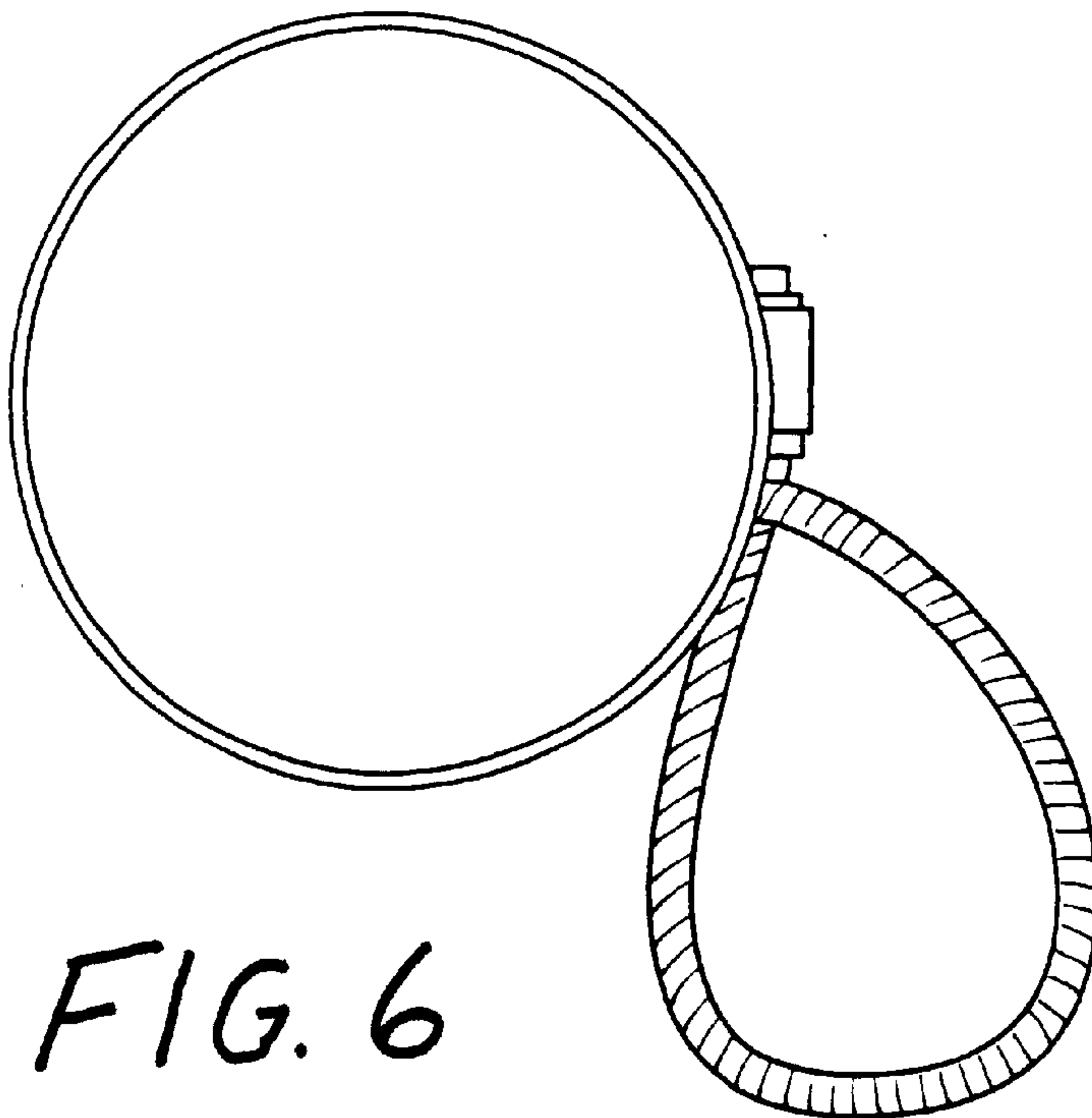

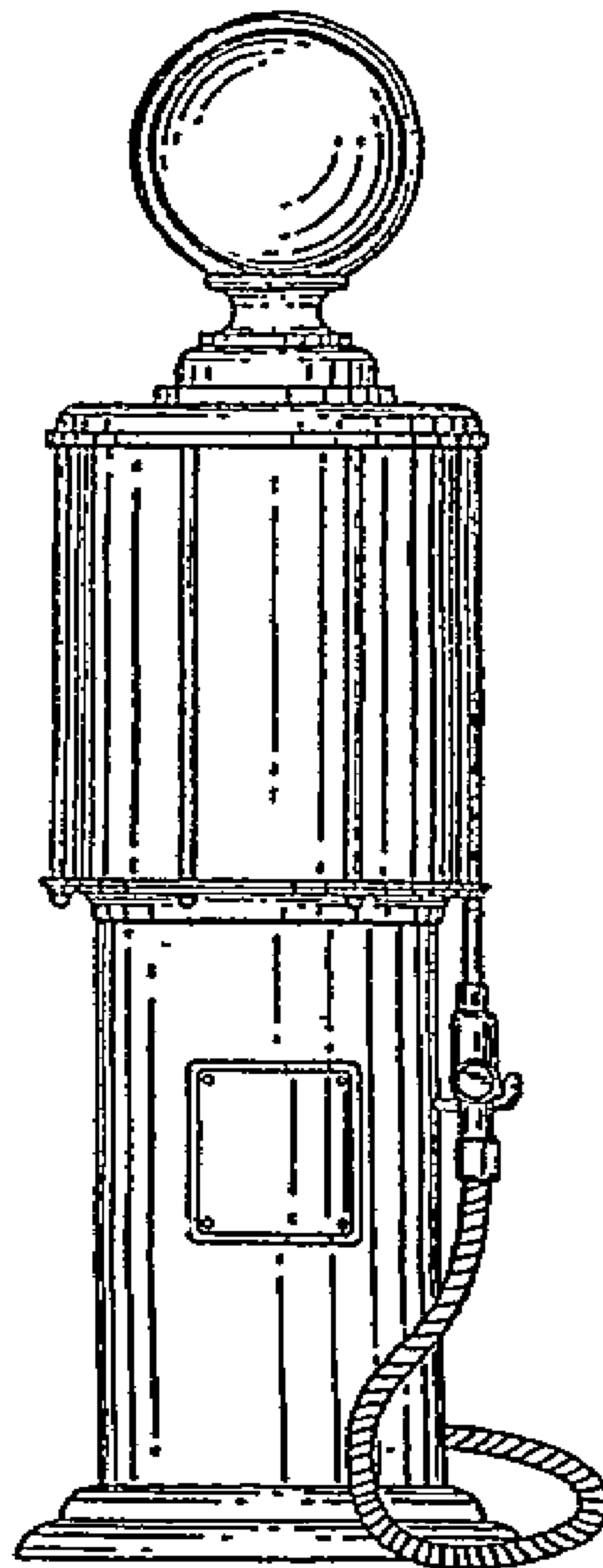
FIG. 3 is a side elevational view thereof, as viewed from the left of FIG. 1;

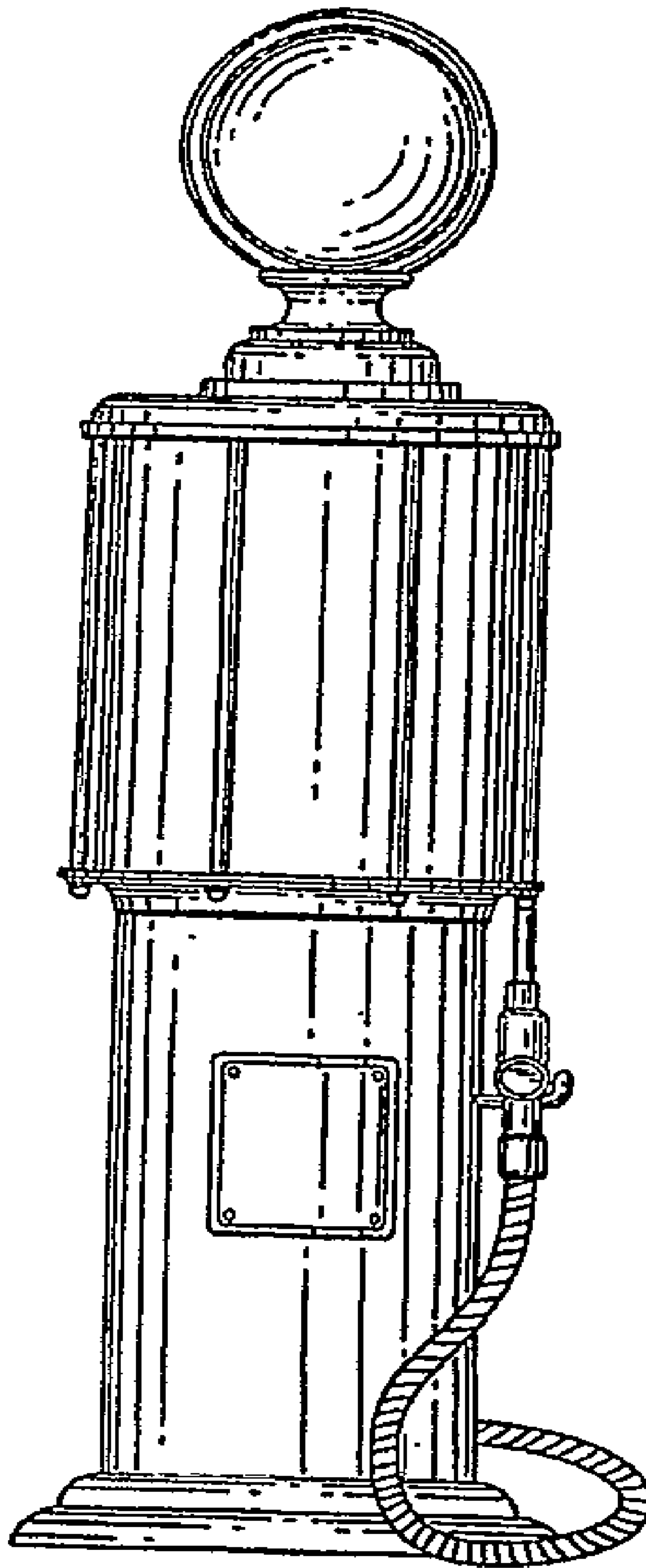

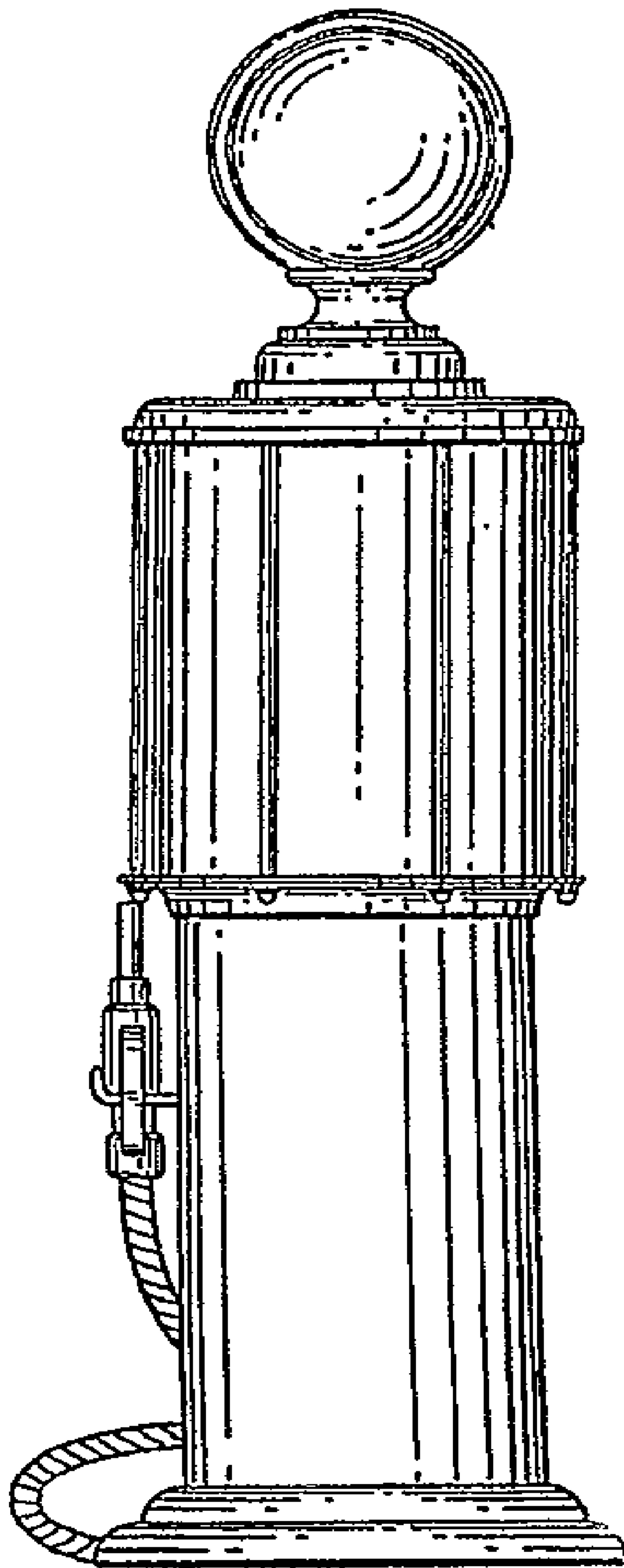

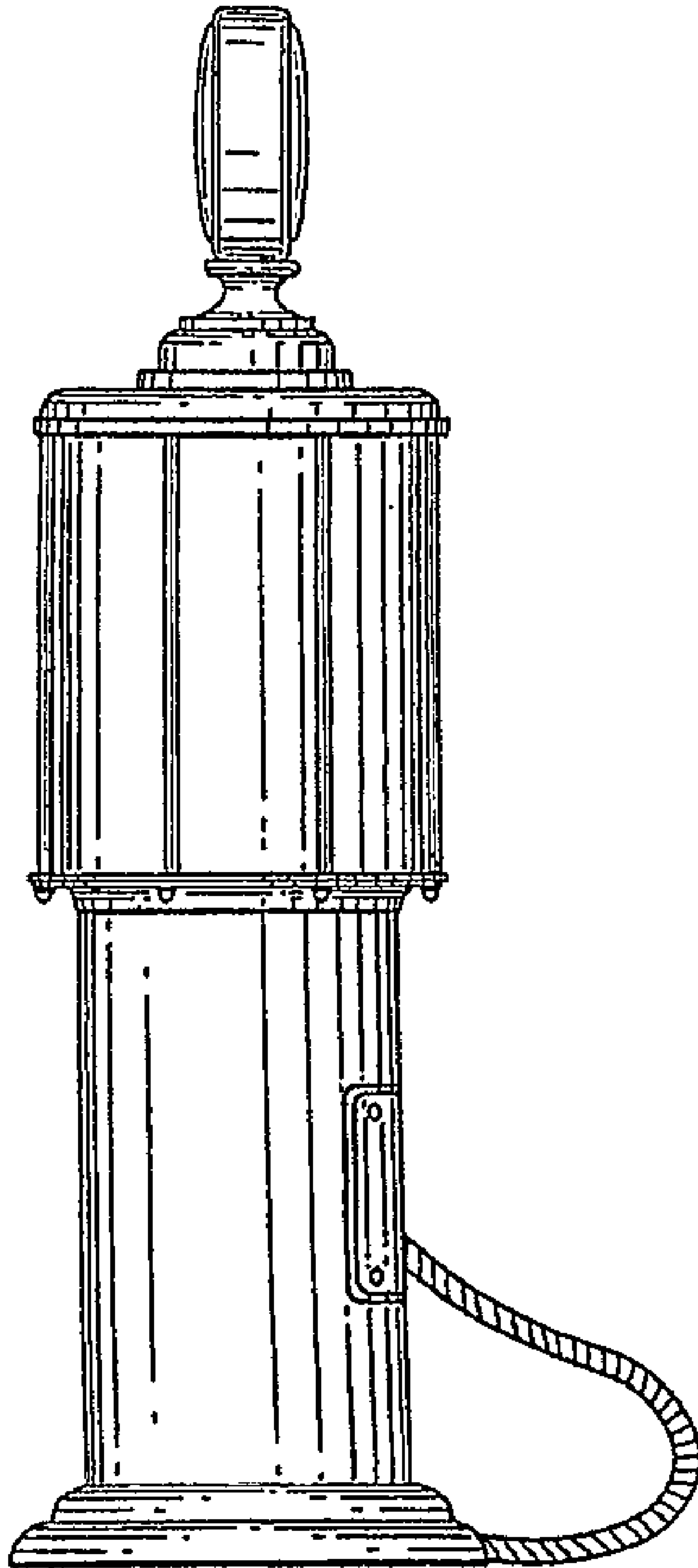

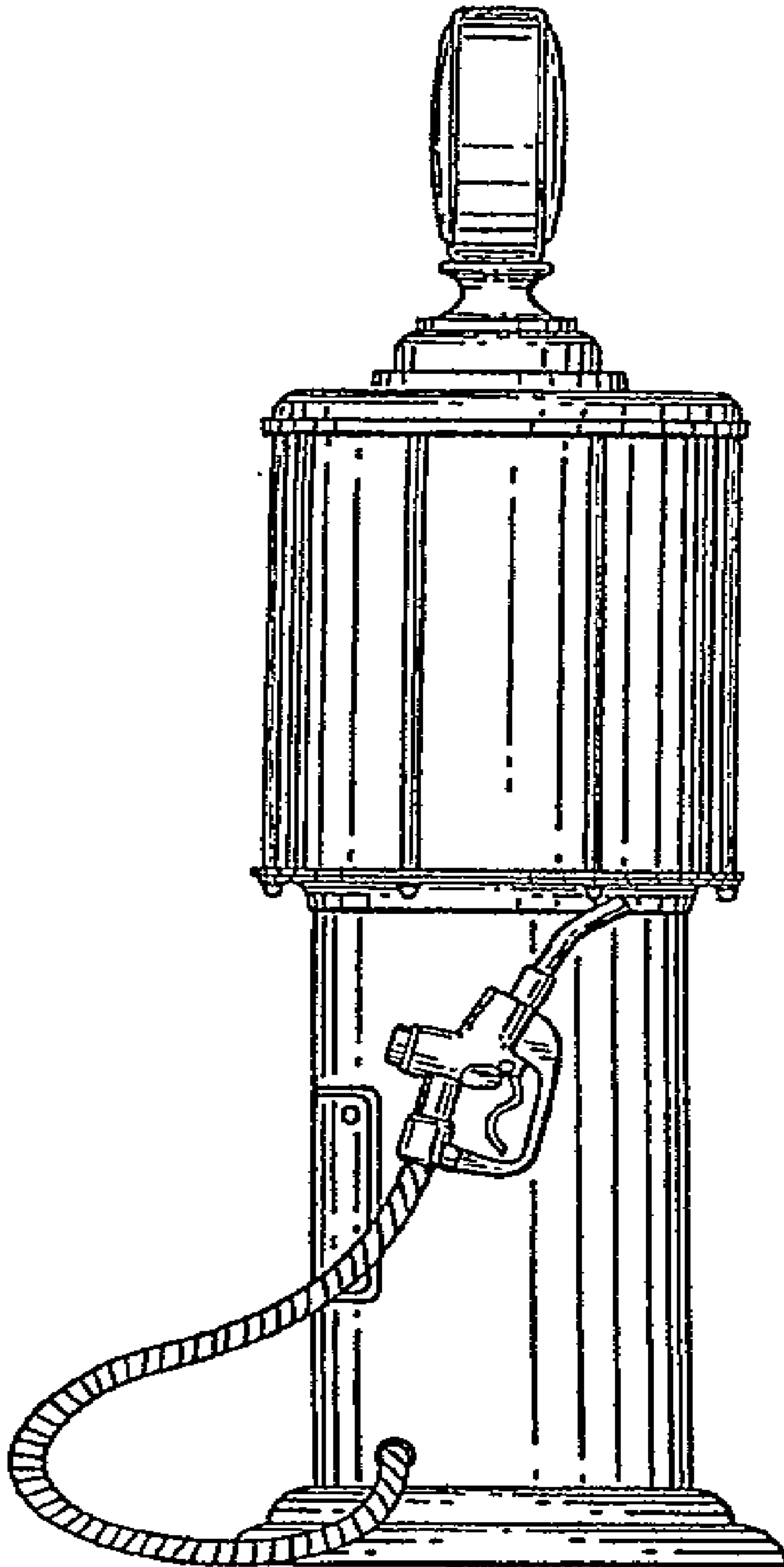

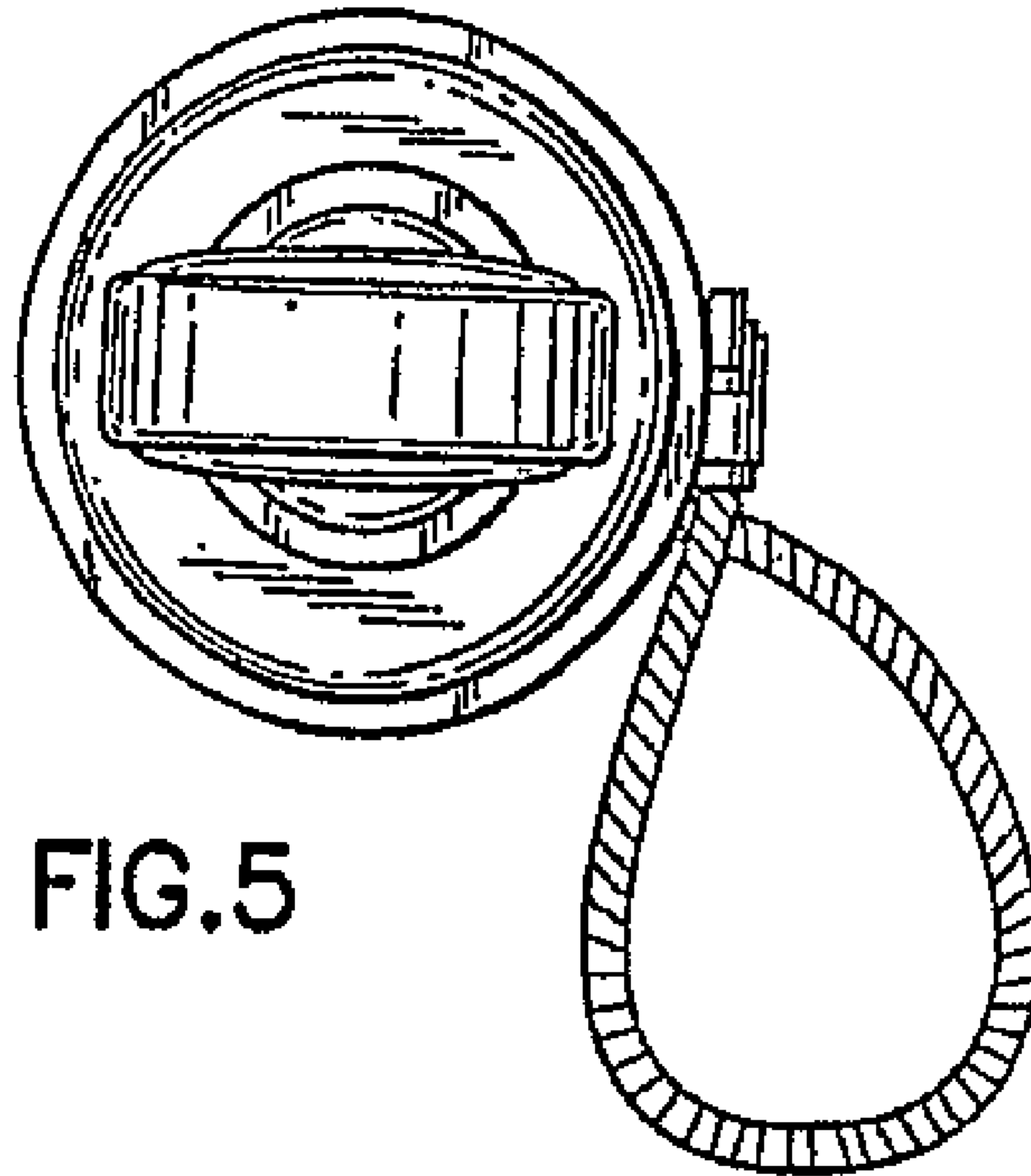

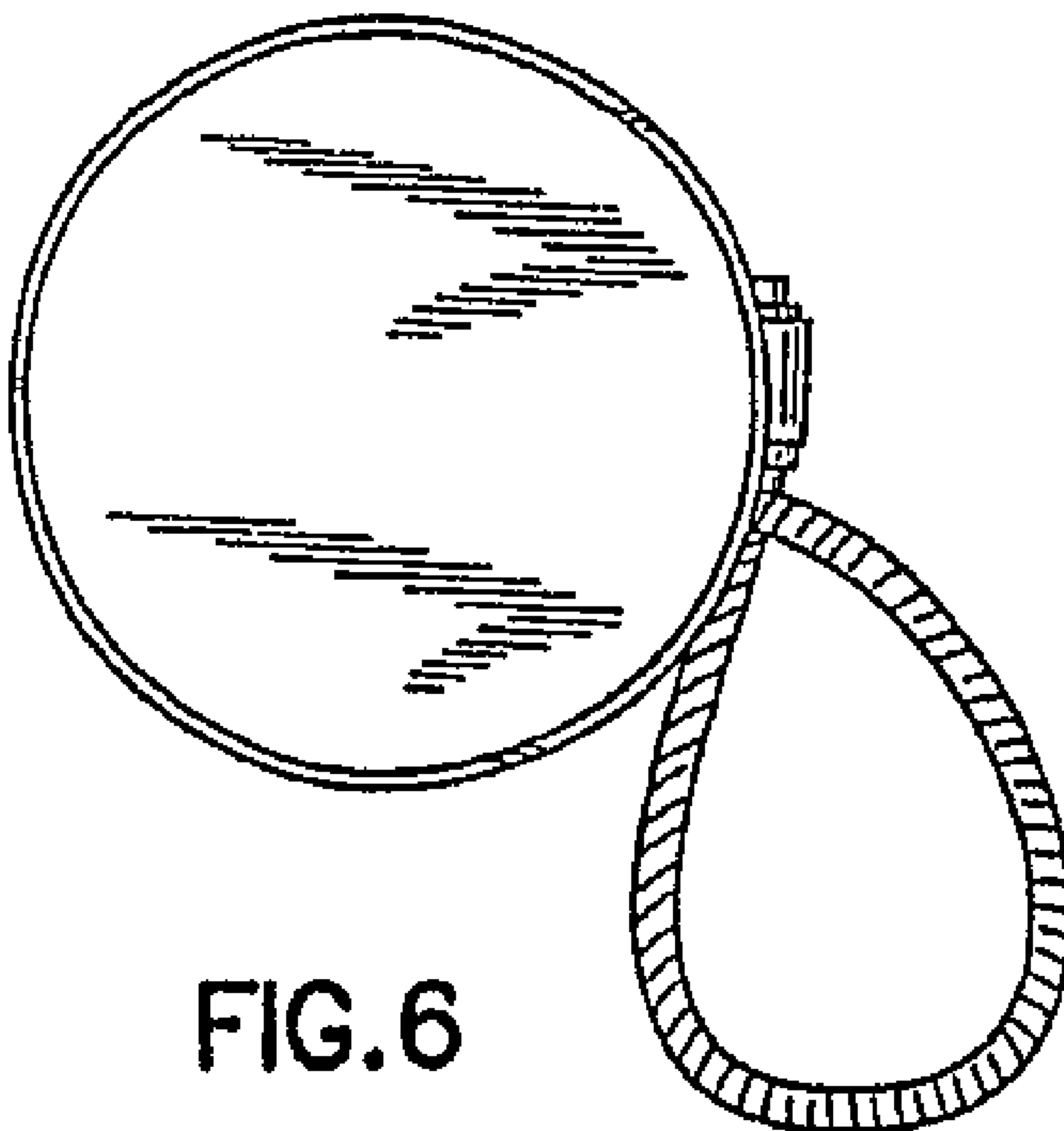
