FIG. 12 is a bottom view thereof.

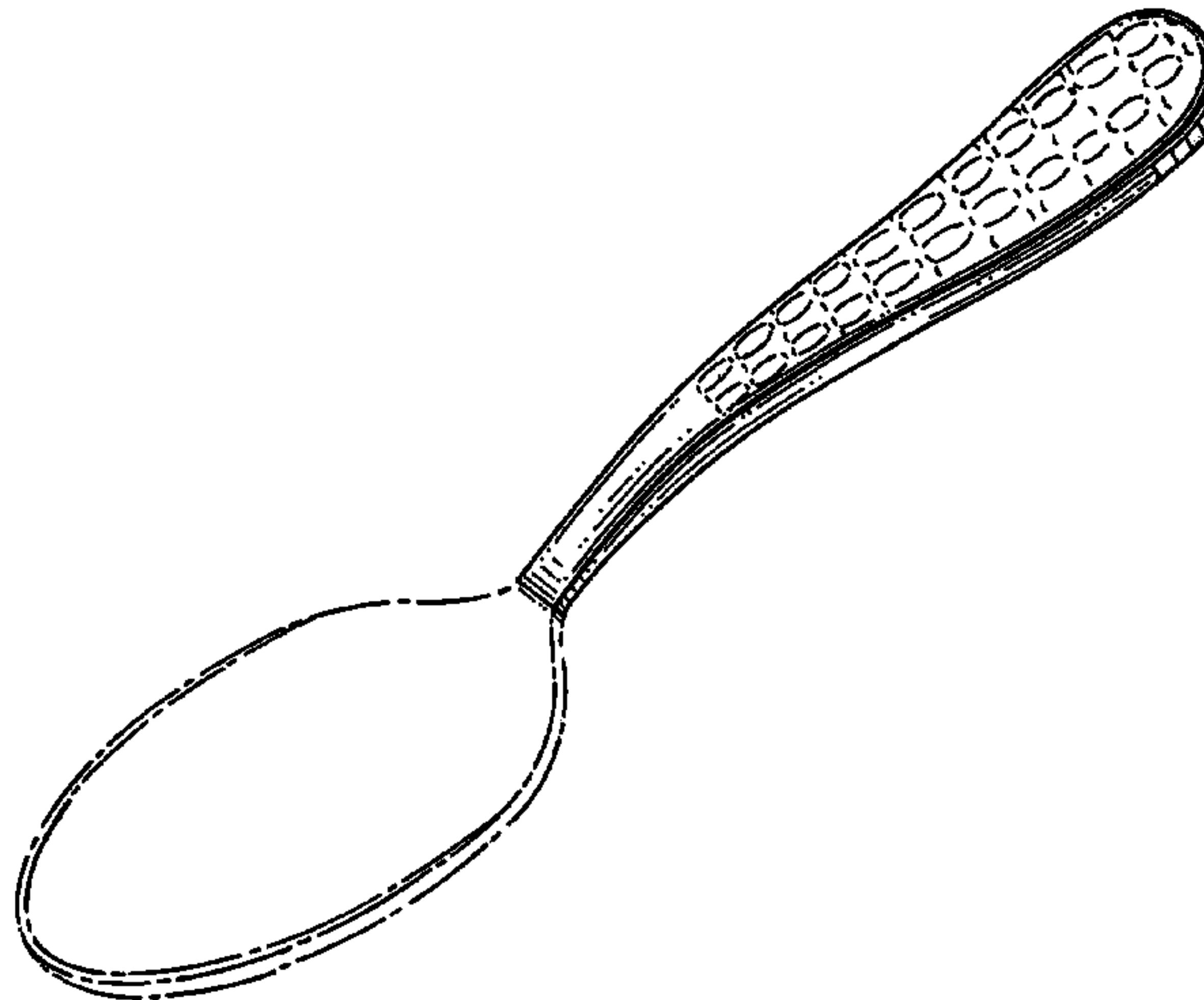
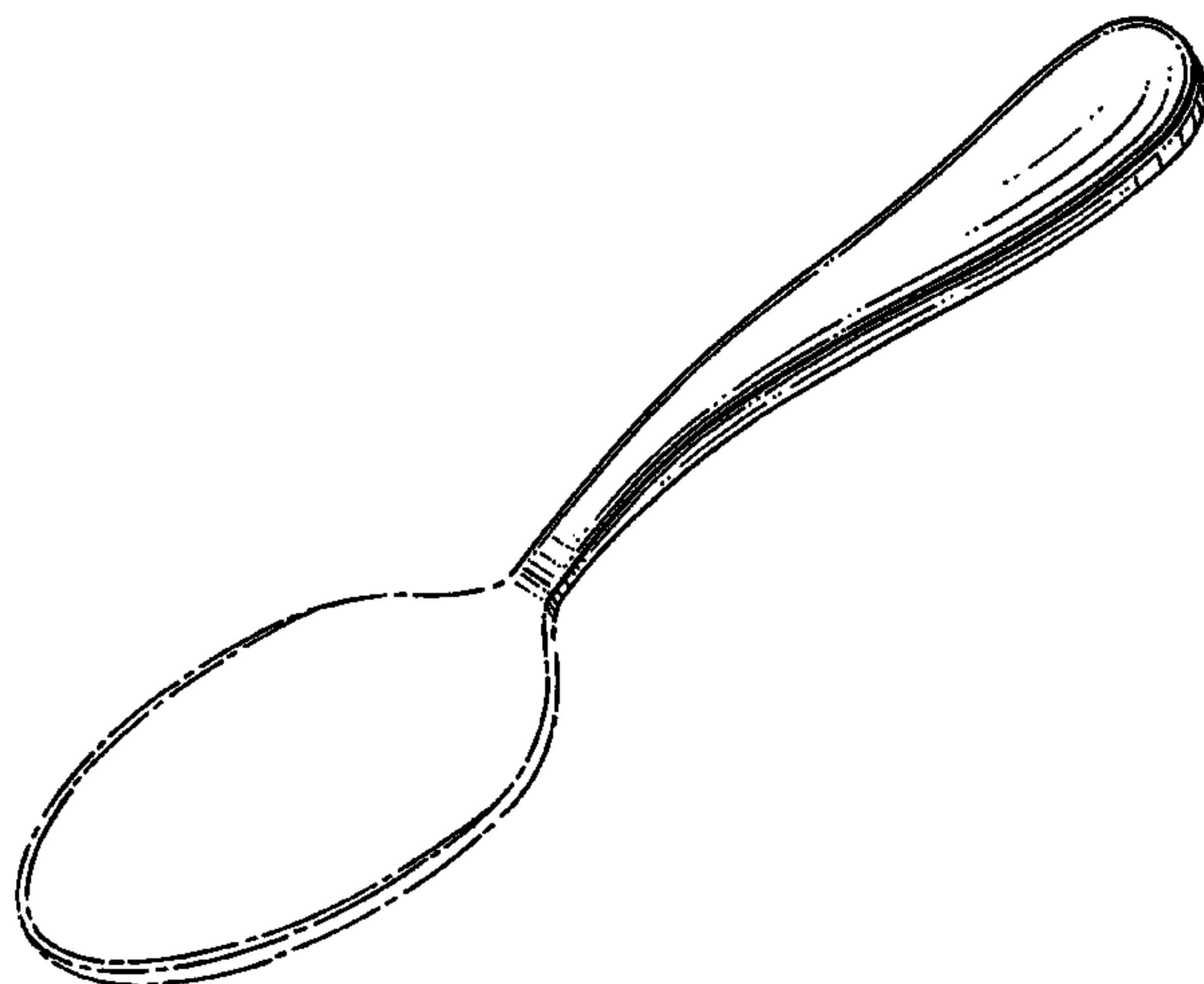

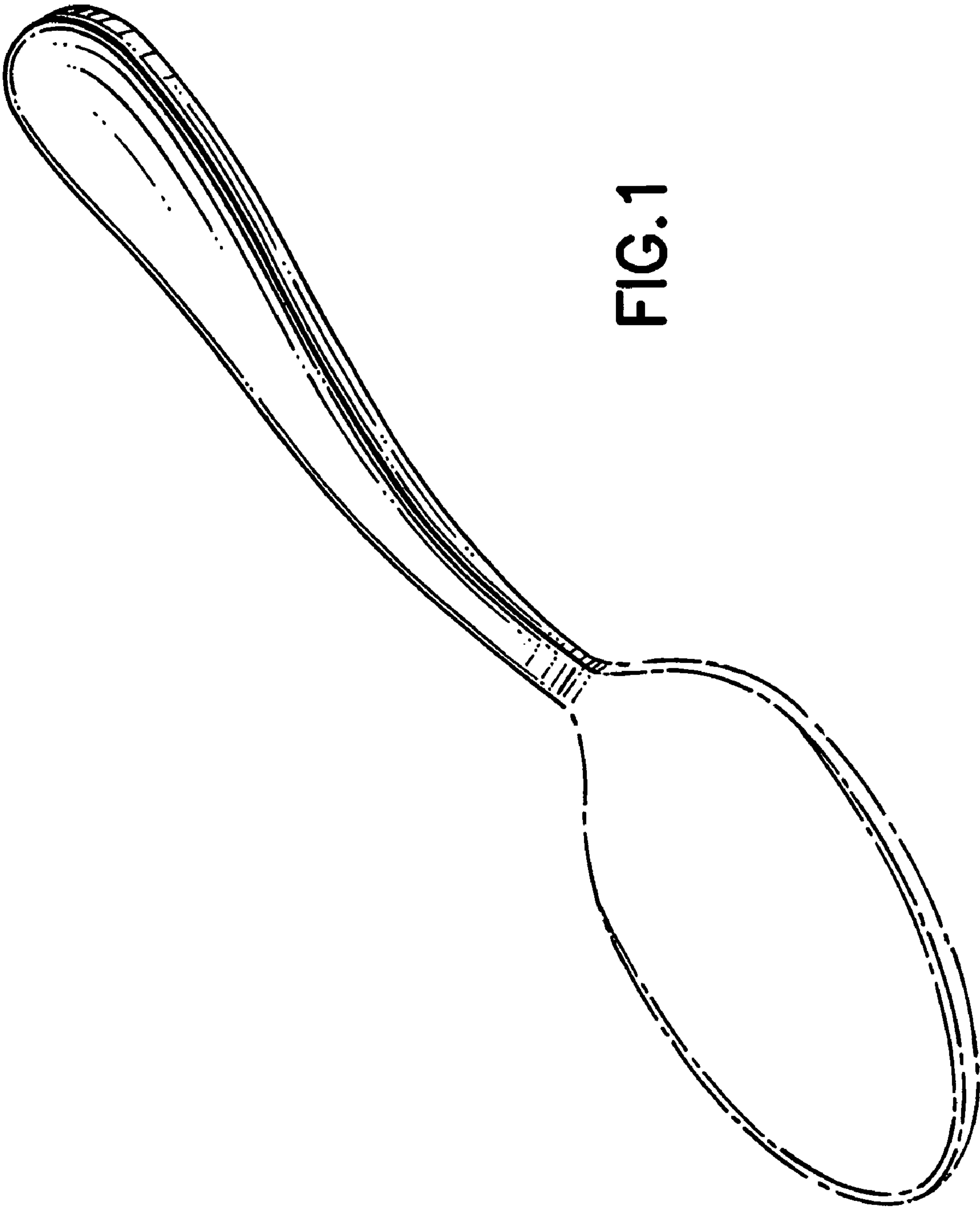

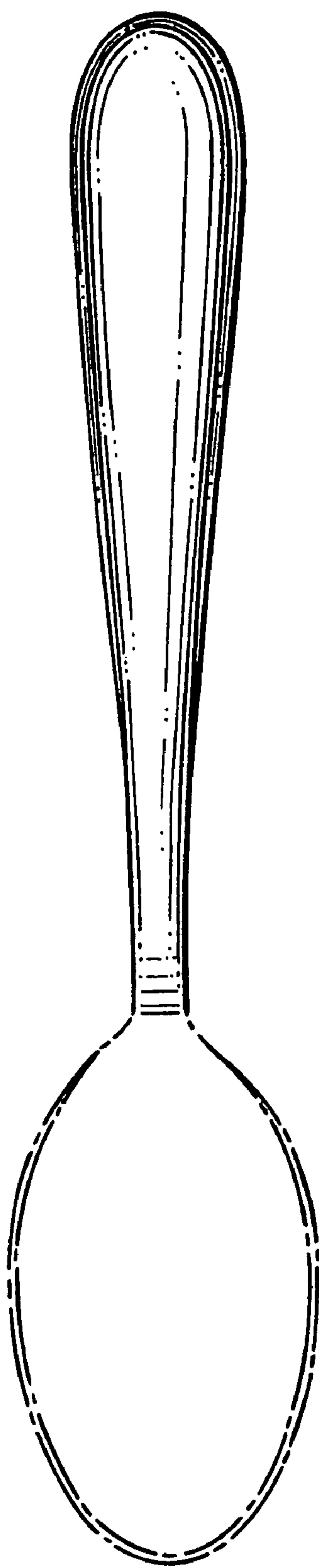

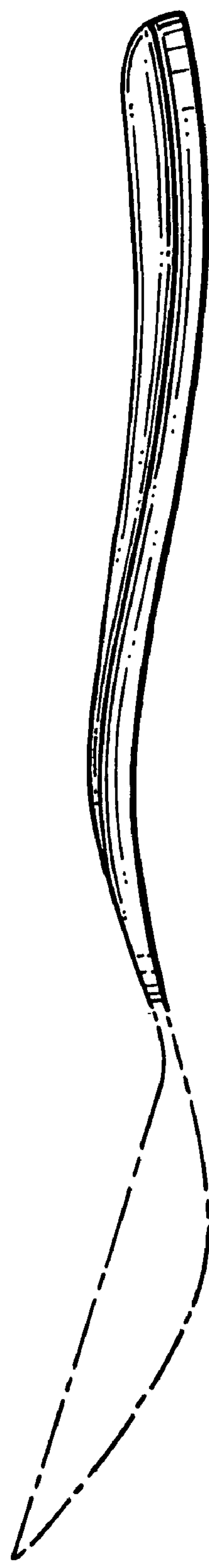

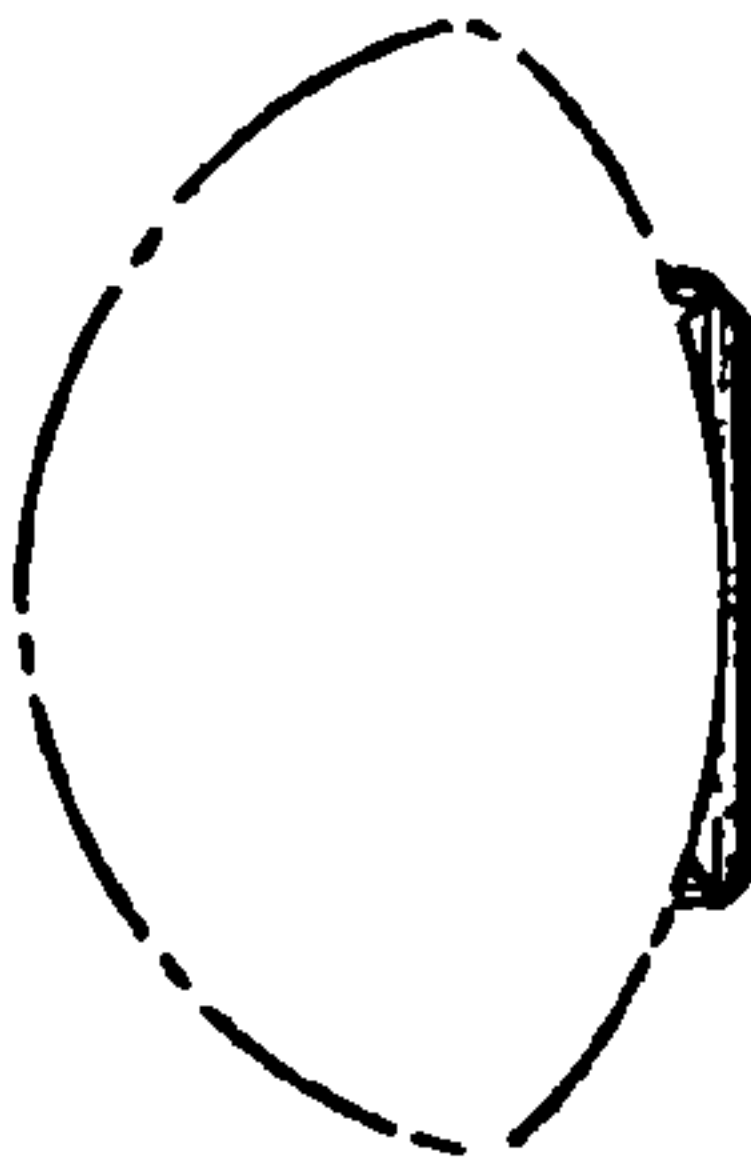

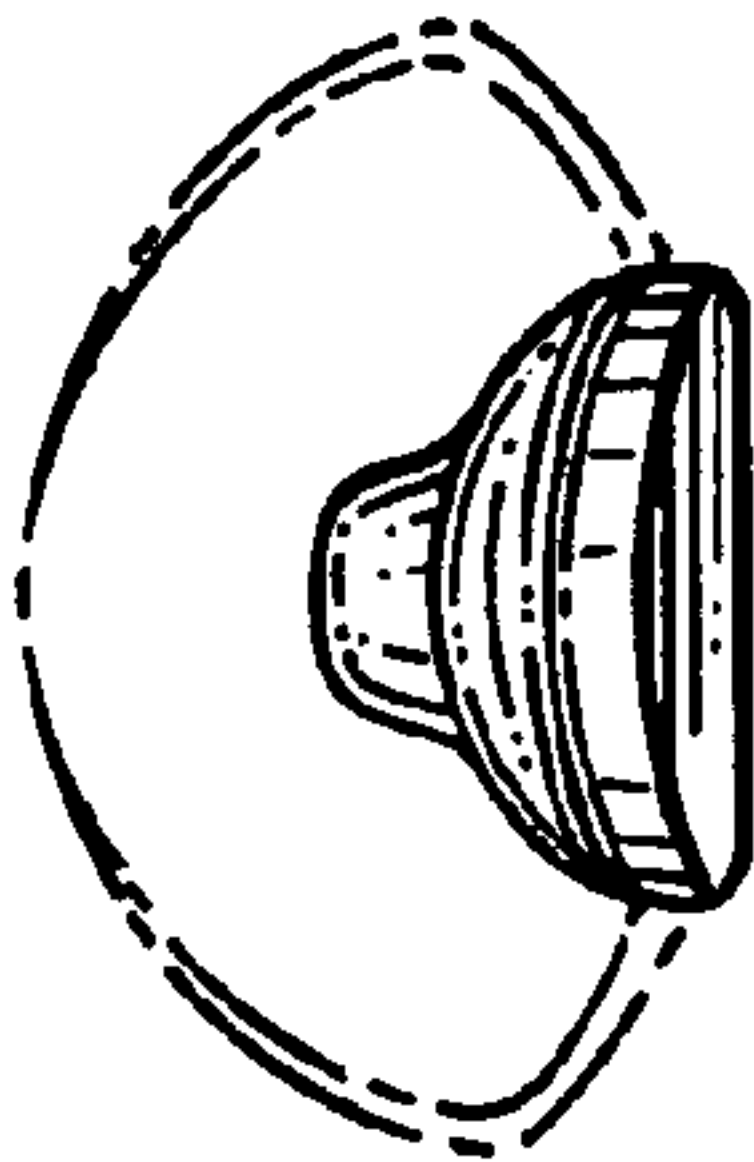
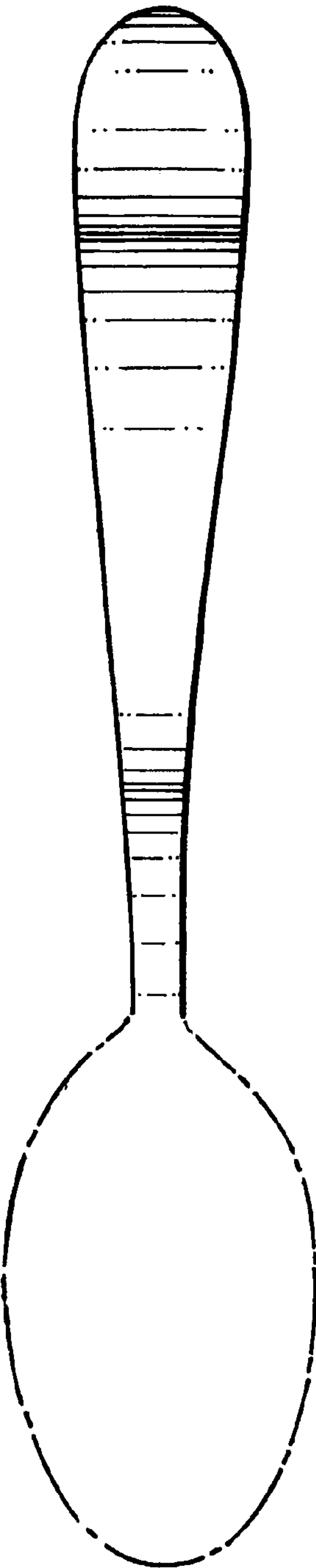

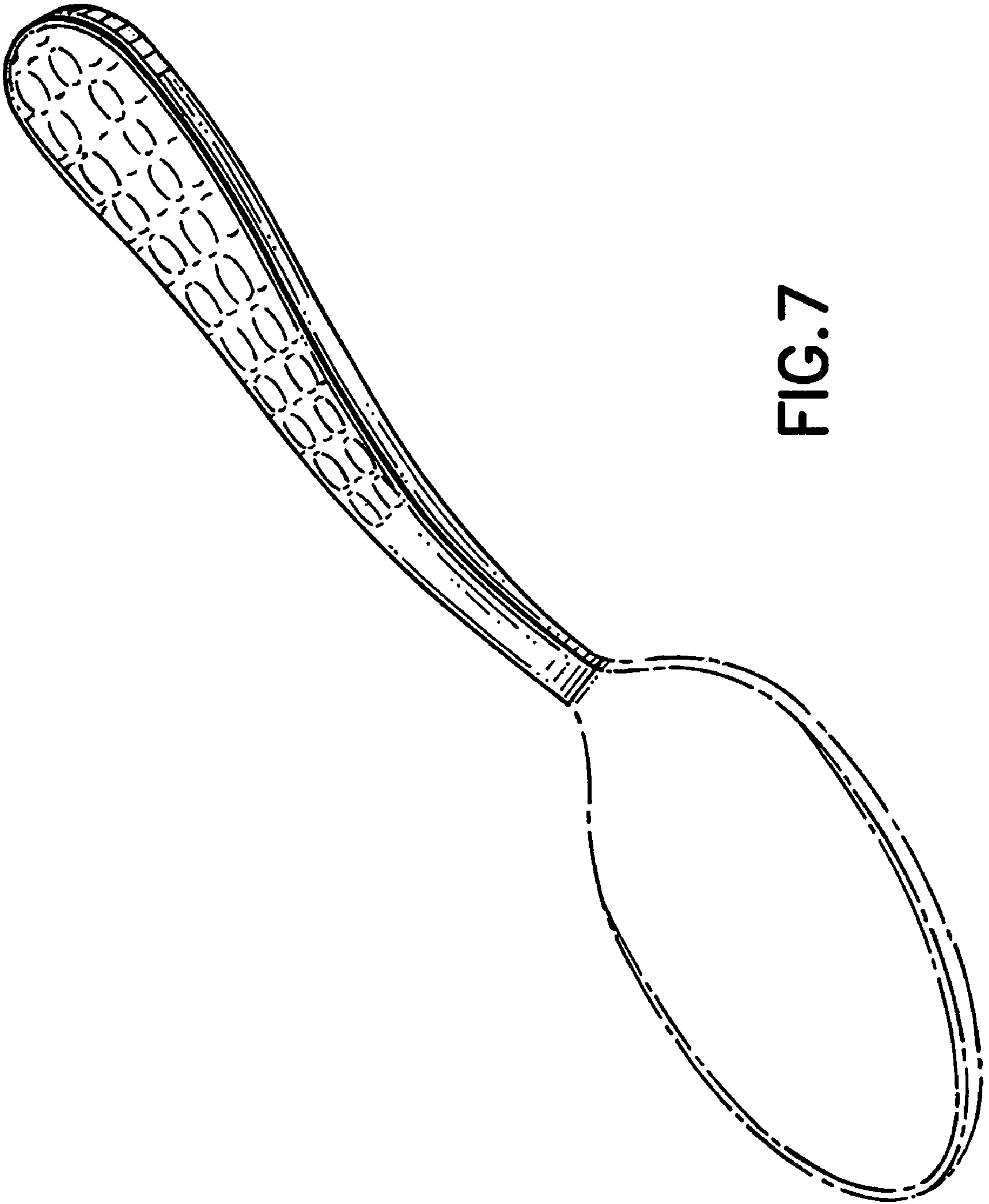

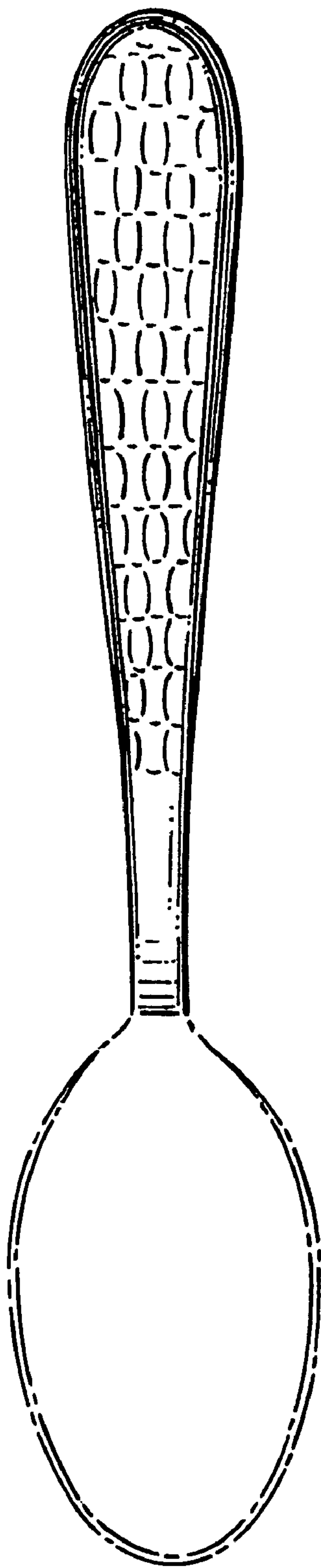

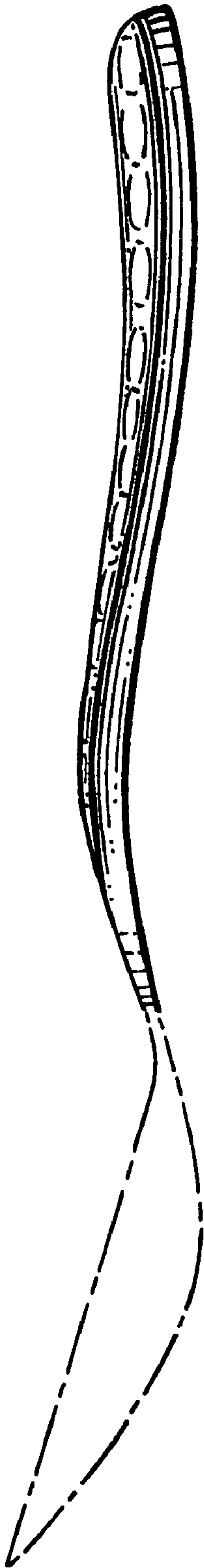

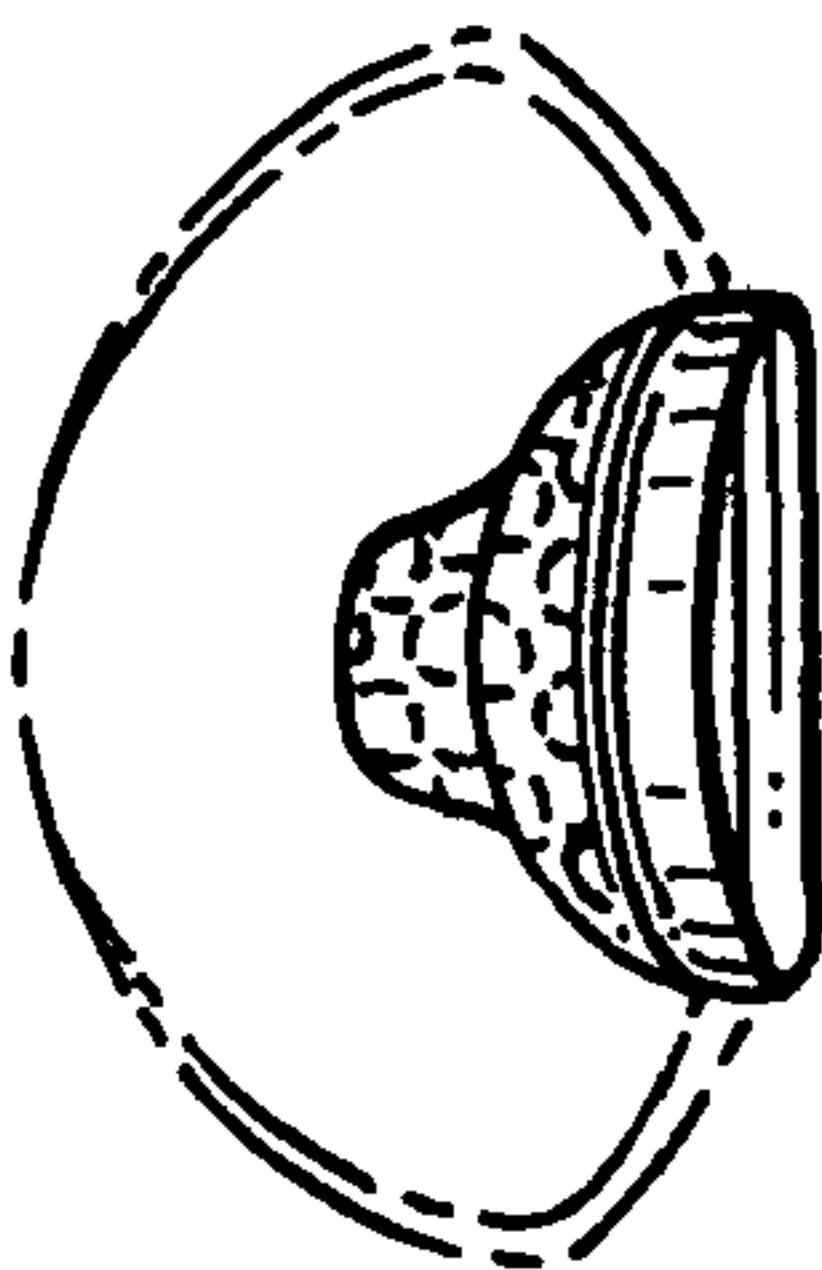

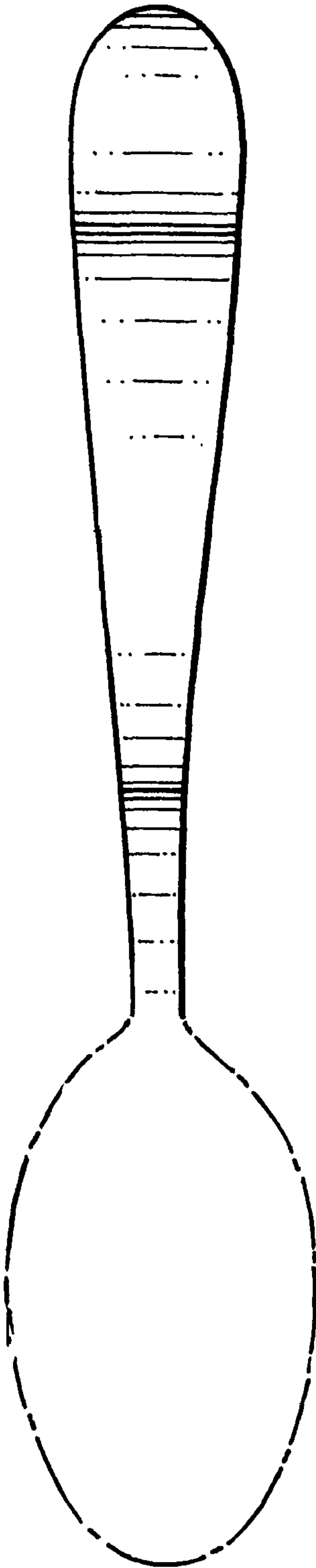
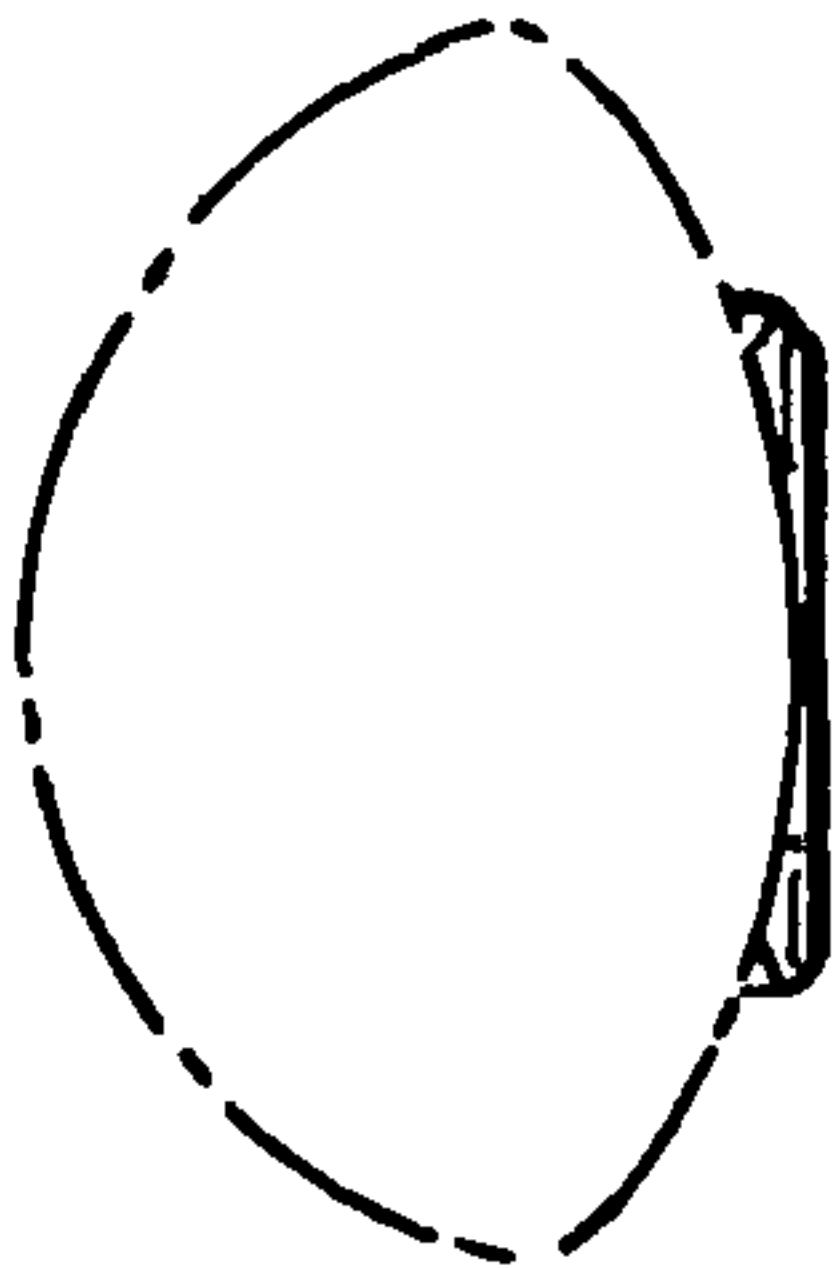
